And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Bath and Wells.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth chapter seventy-seven of the Act of the third and fourth years of Her present Majesty chapter one hundred and thirteen and of the Act of the thirty-seventh and thirty-eighth years of Her said Majesty chapter sixty-three duly prepared and laid before Her Majesty in Council a scheme bearing date the ninth day of May, in the year one thousand eight hundred and ninety-five, in the words and figures following, that is to say:—

"We the Ecclesiastical Commissioners for England acting in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, of the Act of the third and fourth years of Your Majesty chapter one hundred and thirteen and of the Act of the thirty-seventh and thirty-eighth years of Your Majesty chapter sixty-three have prepared and now humbly lay before Your Majesty in Council the following scheme with respect to the two Archdeaconries which are now within the diocese of Llandaff to wit the Archdeaconry of Llandaff and the Archdeaconry of Monmouth and to the rural deaneries comprised within such Archdeaconries.

"Whereas it has been represented to us by the Right Reverend Richard, Bishop of the said diocese of Llandaff, that the arrangements which are hereinafter recommended and proposed with respect to the said two Archdeaconries of Llandaff and of Monmouth, and to certain of the rural deaneries therein are desirable and should be

carried into effect and we are of opinion that the same may be properly carried into effect.

"And whereas the said arrangements involve (inter alia) the transfer of two parishes or cures from the said Archdeaconry of Llandaff to the Archdeaconry of Monmouth aforesaid.

"And whereas it appears to us to be convenient to set forth in the schedule to this scheme annexed the names of all the parishes cures or churches which under the arrangements hereinafter recommended and proposed will be situate within and will constitute the several rural deaneries of the said two Archdeaconries of Llandaff and of Monmouth to the intent that so far as legally may be the said Schedule may be held to be in the place of and in substitution for the Statutory Schedule of Rural Deaneries in the said two Archdeaconries dated the twelfth day of February in the year one thousand eight hundred and seventy-five and prepared under the provisions of the hereinbefore thirdly mentioned Act.

"Now therefore with the consent of the said Richard Bishop of the said diocese of Llandaff (in testimony whereof he has set his hand and affixed his episcopal seal to this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that as from the day on which an Order of Your Majesty in Council ratifying this scheme shall be published in the London Gazette and without any assurance in the law other than such duly gazetted Order the said Archdeaconry of Llandaff and the said Archdeaconry of Monmouth respectively shall comprise and consist of the rural deaneries the names of which are set down in order under the name of each of the said two Archdeaconries respectively in the said Schedule to this scheme annexed, and that the name which in such Schedule is given to any rural deanery shall be the name thereof and that every parish or cure or church the name of which is set down in numbered order in the first column of the said Schedule under the name of the said Archdeaconry of Llandaff or under the name of the said Archdeaconry of Monmouth and under the name of any rural deanery in either of the said two Archdeaconries respectively shall belong to and be and form a part of the Archdeaconry and of the rural deaneries under the respective names of which it appears as aforesaid and shall be subject to the jurisdiction and authority of the Archdeacon of such Archdeaconry and of the rural dean of such rural deanery respectively and shall not belong to or be or form a part of any other Archdeaconry or rural deanery nor be subject to the jurisdiction or authority of any other Archdeacon or rural dean.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other matter or thing with respect to the matters aforesaid or any of them under or by virtue of the said Acts or of any of them or of any other Act of Parliament.
