A T the General Quarter Sessions of the Peace holden by adjournment at Manchester in and for the county palatine of Lancaster the 8th day of July in the year of our Lord 1895.

Whereas at the General Quarter Session of the Peace holden by adjournment at Manchester in and for the county palatine of Lancaster on the 19th day of April last, a Provisional Order was made by this Court in the words following, that is to say:—

Whereas Edward Farrand, Joseph Clegg, James Berry, Stewart Garnett, and Samuel Knowles, Esquires, being five of Her Majesty's Justices of the Peace acting in and for the said county (two of whom, viz., the said Edward Farrand and Joseph Clegg are respectively resident within the district of the said Highway Beard) did by writing under their hands dated the 6th day of April, 1895 require the Clerk of the Peace of the said county to add to or send with the notice required by law to be given of the holding of the next Court of Quarter Session of the Peace for the said county a notice pursuant to the provisions of the Act passed in the 25th and 26th years of the reign of Her Majesty Queen Victoria intituled "An Act for the better Management of Highways in England" or as near thereto as circumstances would admit that at the Court of General Quarter Sessions of the Peace to be held

at Manchester in and for the said county on the

19th day of April last a proposal would be made to the Justices then and there assembled to dissolve the said Highway Board under the provisions of section 39 of the said Act. And whereas in pursuance of such requisition as aforesaid the Clerk of the Peace did on the 9th day of April last send by post in a prepaid registered letter notices in the form aforesaid to the Churchwardens and Overseers of each and every of the parishes, townships and places comprised in such Highway District, and also to the Clerks of the said Highway Board, the Urmston Urban District Council and the Barton - upon - Irwell Rural District Council, and notice thereof was also given by advertisement in the Manchester newspapers.

And whereas a proposal is now made to this Court to dissolve the said Highway Board, and proof having been given to the satisfaction of this Court that the requisition contained in the said writing of the 6th day of April last has been duly complied with by the said Clerk of the Peace and that all the notices required by the said Act of Parliament have been duly given and published.

Now therefore the Justices assembled at this present Court of General Quarter Session of the Peace (being the General Quarter Session of the Peace mentioned in the said requisition and in the said notice) in pursuance of the powers and authorities vested in them under and by virtue of the said Act of Parliament, do entertain the said proposal, and do by this Provisional Order dissolve the said Flixton, Urmston and South Barton Highway District. And lastly the said Justices do hereby direct and appoint that the confirmation of this Provisional Order by a Final Order shall be taken into consideration at the Court of Quarter Sessions of the Peace to be holden at the Assize Courts, Manchester, in and for the said county of Lancaster on the 8th day of July next.

And whereas proof has been given to the satisfaction of this Court that the notices required by the Highway Act 1862 of the making of the said Provisional Order and of the appointment so made by the said Justices in relation to the confirmation thereof have been duly given and published by the Clerk of the Peace of the said County.
