THE Queen has been pleased to appoint the Honourable Mrs. Alaric Grant, and the Honourable Mrs. Bernard Mallet, lately Maids of Honour, to be Extra Women of the Bed-chamber to Her Majesty.

#### Foreign Office, August 10, 1895.

THE Queen has been pleased to approve of Mr. Joaquin Garcia Conde as Consul-General of Mexico at Liverpool; and of Mr. Matthew Proctor as Consul of Austria-Hungary at Cardiff and Newport.

#### Whitehall, August 12, 1895.

THE Queen has been pleased, by Warrant under Her Majesty's Royal Sign Manual, bearing date the 9th instant, to appoint Colin George Campbell, Esq., to be Secretary to the Royal Commission appointed to inquire into the administration and management of the expenditure of India, and into the apportionment of charge between India and the United Kingdom.

#### Whitehall, August 3, 1895.

THE Queen has been pleased to grant unto Sir Rose Lambart Price, Baronet, and to Dame Isabella Elizabeth, his wife, of Hensol Castle, in the county of Glamorgan, Her Royal licence and authority that she, the said Dame Isabella Elizabeth Price, may, in compliance with a clause contained in the last will and testament of Rowland Fothergill, late of Hensol Castle aforesaid, Esquire, deceased, take and henceforth use the surname of Fothergill in addition to and after that of Price, and that she may bear the arms of Fothergill, and that such surname and arms may in like manner be taken, borne, and used by such of her male issue by the said Sir Rose Lambart Price as and when they shall respectively succeed to and be in the actual possession of the rents and profits of certain estates devised by the said will; such arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect :

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.

#### (H. 6616.) Board of Trade (Harbour Department),

London, August 13, 1895. THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, from Her Majesty's Representative at Paramaribo, reporting that in accordance with the Quarantine Laws any vessel passing Fort Amsterdam without anchoring for the visit of the health officer, will be fired at with blank cartridge and must immediately drop her anchor, failing which such vessel shall be liable to a fine of from 25 to 500 guilders, and for a repetition of the offence a fine of 1,000 guilders. No ship having disregarded this ordinance, and become liable to the above-mentioned fines, shall be cleared from the port before having deposited with the Procureur-General the security necessary to cover the fine and costs of such transgression as set forth above.

## (H. 6687.) Boord of Trade (Harbour Department),

London, August 13, 1895. THE Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram from Her Majesty's Representative at Cyprus, reporting that arrivals from Cape Khelidonia to Beyrout, exclusive, shall be subjected to ten days' quarantino, unless they have undergone quarantine at an intermediate port, and have a clean bill of health.
