#### MERCHANT SHIPPING ACT, 1894.

N OTICE is hereby given that, after the expiration of forty days from the date hereof, it is proposed to submit to Her Majesty in Council, in pursuance of the above-mentioned Act, the draft of an Order in Council exempting from re-measurement for tonnage in this country Merchant Ships of the Kingdom of Denmark, the measurement whereof shall, on and after the 1st April last, have been ascertained and denoted in the Certificates of Registry or other national papers of such ships.

And notice is hereby further given that, in accordance with the provisions of the Rules Publication Act, 1893, copies of the proposed draft Order in Council can be obtained by any public body, within forty days of the date of this notice, at the Privy Council Office, Whitehall.
