(1.) Christiania Fiord—Drams Fiord—Alterations in Svelvik Strom Lights.

W.; from S. 22° W., through west, to N. 13° W., it is obscured : it shows red from N. 13° W., through north, to N. 9° E.; and white from N. 9° E. to N. 13° E.

It is elevated 50 feet above high water, and shown from a wooden framework structure, situated on Chart No. 1974 in approximately lat. 59° 36' 15" N., long. 10° 25' 10" E.

3. The rear Tömmeraas Light (fixed red) is visible from N. 34° W. to N. 18° W., elevated 98 feet above high water, and situated N. 28° W., distant 602 yards, from the light on Batteriöen.

Bornholm-Intended Additions and Alterations in Lights and Fog Signals at Hammer Point.

THE Danish Government has given notice that, during the autumn of 1895, a new light will be shown from a lighthouse recently erected at Hammer Point, north end of Bornholm :-

Hammer Odde Light will be a group flashing white light, with a period of system of ten seconds, thus :--flash, a tenth of a second ; eclipse, two and four-tenths seconds; flash, a tenth of a second ; eclipse, seven and four-tenths seconds.

It will be elevated 66 feet above high water, visible 13 miles in clear weather, and shown from a white, rectangular tower, 38 feet high, situated approximately in latitude 55° 18' 0" N., longitude 14° 46' 45" E.
