*Alhucemas Light—Position Temporarily Altered.*

THE Spanish Government has given notice, dated 17th September, 1895, that, in consequence of alterations in progress at Alhucemas Light-house, the light has been temporarily moved to a position 131 feet south-eastward, and is 97 feet above water. It shows red from S. 63° E., to S. 5° W., white from S. 5° W., through west to N. 63° W., and green from N. 63° W. to N. 6° E.
