(S. 87° E.), distant three-quarters of a mile from Summerside Railway Wharf Lighthouse (a).

The above lights in line, bearing S. 87° E., lead in the channel from abreast Indian Spit to Summerside Railway Wharf, in a depth of not

less than 15 feet at low water.
