> ORDER OF THE BOARD OF AGRICULTURE.

(DATED 5TH DECEMBER 1895.)

(Swine-Fever Infected Area.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Act, 1894, and of every other power enabling them in this behalf, do order, aud it is hereby ordered, as follows: 1. The parishes and part of the parish described

1. The parishes and part of the parish described in the Schedule to this Order, being portions of the following Area declared by Order of the Board dated the thirteenth day of September, one thousand eight hundred and ninety-five, to be an Area infected with swine-fever for the purposes of the Swine-Fever (Infected Areas) Order of 1894, No. 3 (namely),—the county of Essex (except the Landing-Place for Foreign Animals at Thames Haven in the Port of London), and also comprising the boroughs of Colchester and Southend-on-Sea, — are hereby declared to be free from swinefever, and the portions above described shall as from the commencement of this Order cease to be in an Area infected with swine-fever.

2. This Order shall come into operation on the eleventh day of December, one thousand eight hundred and ninety-five.
