**ELEMENTARY EDUCATION ACTS,
1870-1893.**

THE Lords of the Committee of the Privy Council on Education have issued an order this day, in pursuance of an Order made under the Local Government Act, 1894, for the election of one person by the part of the Parish of Overstrand (County of Norfolk) added to the Parish of Cromer, to sit on the School Board for Cromer. County of Norfolk.

THE Queen has been pleased to grant unto Edward Annesley Pegge-Burnell, of Dunston Hall, in the parish of Chesterfield, in the county of Derby, Esquire, a Major in Her Majesty's Army, Her Royal licence and authority that he and his issue may take and henceforth use the surnames of Smith and Milnes in addition to and after those of Pegge and Burnell, that he may be called Edward Annesley Pegge-Burnell-Smith-Milnes, that he may bear the arms of Milnes, Smith, Burnell, and Pegge quarterly, and that the said surnames and arms of Milnes and Smith may in like manner be assumed and used by his issue; the said arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
