IN pursuance of the powers conferred on me by "The Wild Birds Protection Act, 1894," and, upon application by the County Council of the Administrative County of Northampton, I hereby

make the following Orders:—
(1.) "The Wild Birds Protection Act, 1880," shall apply within the whole of the County of Northampton, to the Heron, Hawks (Buzzard, Honey Buzzard, Kestrel, Merlin, Hobby, Osprey, and Hen Harrier), Nuthatch, Wryneck, as if those species were included in the Schedule to that Act.

(2.) The time during which the taking and killing of Wild Birds is prohibited shall, so far as regards the Heron, be extended so as to be from

the 1st March to the 1st September.

(3.) The taking or destroying of the Eggs of the Goldfinch, Hawks (Buzzard, Honey Buzzard, Kestrel, Merlin, Hobby, Osprey, and Hen Harrier), Kingfisher, Nightingale, Nightjar (Goatsucker, Night Hawk or Fern Owl), Nuthatch, Owls, Sandpiper (Summer Snipe), Woodpeckers, Wryneck (Cuckoo's Mate or Snake Bird), is prohibited throughout the County of Northampton.
