

"Whereas by the authority of an Order of Your Majesty in Council, bearing date the twentieth day of December in the year one thousand eight hundred and eighty-five and published in the London Gazette upon the first day of January in the year one thousand eight hundred and eighty-six ratifying a scheme of the Ecclesiastical Commissioners for England prepared under the provisions of the Act of the third and fourth years of Your Majesty, chapter one hundred and thirteen, of the Act of the sixth and seventh years of Your Majesty, chapter thirty-seven, of the Act of the nineteenth and twentieth years of Your Majesty, chapter one hundred and four, a certain part of the parish of Aston-juxta-Birmingham in the county and diocese aforesaid was constituted a separate district for spiritual purposes and the same was called 'The District of Saint Basil Deritend.'

"And whereas no church has yet been provided for or consecrated within the said district of Saint Basil, Deritend.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said district should be altered by way of extension so that they shall include the portions hereinafter described of the new parish of Saint Andrew Bordesley and of the new parish of The Holy Trinity Bordesley both in the said county of Warwick and in the diocese of Worcester aforesaid.

"Now therefore with the consent of the Right Reverend John James Stewart Bishop of the said diocese of Worcester (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation the boundaries of the said district of Saint Basil, Deritend shall be altered by way of extension so that they shall include all those portions of the said new parish of Saint Andrew Bordesley and of the said new parish of The Holy Trinity Bordesley which are described in the schedule hereunder written and are delineated and set forth on the map or plan hereunto appended and are thereon coloured pink and green respectively. And that from and after the said day of publication as aforesaid and without any assurance in law other than such duly gazetted Order the said portions of the said new parish of Saint Andrew Bordesley and of the said new parish of The Holy Trinity Bordesley so to be included within the boundaries of the district of Saint Basil, Deritend as aforesaid shall become and be and form part of the same district.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing Scheme or Representation has reference.

"The territory to be annexed to the district of Saint Basil Deritend in the county of Warwick and in the diocese of Worcester being:—

"I. All that portion of the said new parish of Saint Andrew, Bordesley which is bounded upon the north-west by the new parish of Ashted in the said county and diocese, upon the west partly by the said district of Saint Basil, Deritend and partly by the new parish of The Holy Trinity Bordesley in the county and diocese aforesaid upon the south

by the last named new parish and upon the remaining sides, that is to say, upon the east and upon the north-east by an imaginary line commencing upon the boundary which divides the said last named new parish from the new parish of Saint Andrew, Bordesley aforesaid at the point where Kingston-road, Adderley-street and Watery-lane all meet, and extending thence northward along the middle of the said lane for a distance of twenty-seven chains or thereabouts to its junction with Lower Dartmouth-street and with Lawley-street and extending thence north-westward along the middle of the last-named street for a distance of seven chains or thereabouts to a point at or near to the junction of such last-named street with Garrison-street upon the boundary which divides the said new parish of Saint Andrew Bordesley from the new parish of Ashted aforesaid.

"II. All that portion of the said new parish of The Holy Trinity Bordesley which is bounded upon the north-west by the said district of Saint Basil, Deritend upon the north-east by the above described portion of the new parish of Saint Andrew, Bordesley and upon the remaining sides that is to say upon the south upon the south-east and upon the south-west by an imaginary line commencing upon the boundary which divides the said new parish of Saint Andrew Bordesley from the new parish of The Holy Trinity Bordesley aforesaid at the centre of the bridge which carries Adderley-street aforesaid over the Warwick and Birmingham Canal and extending thence first westward and then south-westward along the middle of the last-named street for a distance of eighteen chains or thereabouts to its junction with High-street, Bordesley and extending thence north-westward along the middle of the last-named street for a distance of one chain and a half or thereabouts to the point opposite to the passage leading into Alcester-street where the boundaries of the said new parish of The Holy Trinity Bordesley of the said district of Saint Basil, Deritend and of the new parish of Saint John, Deritend in the county and diocese aforesaid all meet.

"And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have with one exception respectively signified their assent thereto.

"And whereas the incumbent of the said new parish of Saint Andrew Bordesley has offered certain objections to the said scheme or representation."

And whereas the said scheme or representation has notwithstanding such objections been approved by Her Majesty in Council: Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Worcester. *C.
