2. Quarantine for seven days to be reckoned from the commencement of the voyage, with permission for handling the cargo in quarantine.

The following shall be subjected to a period of seven days' quarantine, but shall be permitted, under the directions of the Collector of Customs, to discharge goods (which are not susceptible of communicating contagion) by means of the vessel's crew on lighters, or to employ for handling cargo local labourers subject to seven days' quarantine.

Vessels from Egypt with passengers arriving from Port Saaid, excepting vessels that carry a certified medical officer, who shall declare that no suspicious symptoms have occurred on board during the voyage, and excepting vessels of which the master certifies that no passengers or crew have been taken at Port Saaid.
