ORDER of the Local Government Board: Temporary Workhouse: Regulations:-

Parish of Saint Mary, Islington. To the Guardians of the Poor of the Parish of Saint Mary, Islington ;-

To the Overseers of the Poor of the said Parish ;—

And to all others whom it may concern.

WHEREAS by an Order dated the 4th day of July, 1867, addressed to the Guardians of the Poor of the said Parish of Saint Mary, Islington, and by a General Order dated the 12th day of February, 1879, addressed to the said Guardians (amongst others) the Poor Law Board, and We; the Local Government Board, prescribed Rules and Regulations relating to the government of the Workhouse of the said Parish, the appointment by the said Guardians of Officers and Assistants at the said Workhouse, and the duties, remuneration, and continuance in office of such Officers and Assistants;

And whereas by an Order dated the 13th day of July, 1868, addressed to the said Guardians, the Poor Law Board prescribed Regulations for the keeping, examining, auditing, and allowing of the Accounts of the said Guardians and their Officers, including the Accounts relating to the

said Workhouse;

And whereas the said Guardians have, with Our approval, acquired certain premises known as Bowes Manor, at Southgate, in the County of Middlesex, which they propose to use as a temporary Workhouse for the accommodation of adult pauper inmates chargeable to the said Parish:

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order as follows :-

ARTICLE I .- The several Orders above mentioned, so far as they are applicable to the said temporary Workhouse, and subject as hereinafter mentioned, shall apply to such temporary Work-

house accordingly.

ARTICLE II.—Article 178 of the said Order of the 4th day of July, 1867, relating to the remuneration of Officers and Assistants, and Article 196 of that Order and Article 1 of the said Order of the 12th day of February, 1879, relating to the continuance in office of Officers or Assistants, are hereby suspended with respect to the said temporary Workhouse.

ARTICLE III.—Every Officer or Assistant at the said temporary Workhouse shall be appointed for such term and at such salary or remuneration as the said Guardians may determine; but the particulars of every such appointment, including the name of the Officer or Assistant, the term for . which he is appointed, and the salary or remuneration assigned to him, shall be reported to Us by the Clerk to the said Guardians as early as practicable.

ARTICLE IV.—Every such Officer or Assistant may be dismissed by the said Guardians at their
