Black Cap Warbler, Buntings, Chiff Chaff, Cole Tit, Ducks (Wild) all species, Fly Catchers, Fire-crested Wren, Golden-crested Wren, Goldfinch, Lesser (Dab Chick) Grebe, Great Crested Grebe, Hawks, Buzzard, Honey Buzzard, Kestrel, Merlin, Hobby, Osprey, Kingfisher, Lesser White-throat, Long-tailed Tit (Bottle Tit, Jack-o'-Bo-Peep), Marsh Tit, Martins, Nightingale, Night Jar (Goatsucker, Night Hawk, or Fern Owl),-Nuthatch, Owls, Rails (Land and Water), Redstart, Reed Warbler, Sandpiper (Summer Snipe), Shrikes (Butcher Birds), Sedge Warbler, Swallow, Swift, Tree Creeper, Wagtails, Willow Wren, Wryneck Whitethroat, Woodpeckers, Wren, (Cuckoo's Mate or Snake Bird).

2. "The Wild Birds Protection Act, 1880," shall apply within the Administrative County of Leicester to the following species of Wild Birds in the same manner as if those species wereincluded in the Schedule to the Act :-

Hedge Sparrow, Spotted Fly Catcher, Pied Fly Catcher, Tree Creeper, Sand Martin, Martin, Swallow, Wagtails, Swift.

DISEASES OF ANIMALS ACT, 1894.

THE Board of Agriculture approved on the 5th day of May 1896 of an Agreement made between the Councils of the counties of Hereford and Salop under the provisions of section 39 of the above Act whereby it is provided that the Local Authority of the county of Salop shall exercise within so much of the parish of Leintwardine in the county of Hereford as lies to the north and west of the road leading from Bedstone Village by Heath House to Hopton Heath inclusive of the said road such of the powers contained in the Diseases of Animals Act 1894 and any Order of the Board of Agriculture made thereunder as relate to the making and enforcing of orders forregulating or prohibiting the movement of animals into the district of a Local Authority from the district of any other Local Authority and shall carry out and enforce the same; and for the
