(New Storage Reservoirs, Aqueducts, Conduits, Cuts, Lines of Pipes, and other Works in Counties of Middlesex and Essex; Diversion of Pootpath and New Footbridge in Parishes of Walthamstow and Tottenham; Dredging, &c., of part of Tottenham Mill Lead; Taking, Diversion, &c., of Waters, &c., from River Lee, Tottenham Mill Lead, Ching Brook, and Chingford Mill Street Leaders. Chingford Mill Stream; Incorporation of certain Provisions of Railways Clauses Consolida-tion Act, 1845; Extension to Company's Undertaking of the Provisions or some of the Provisions of Waterworks Clauses Acts, 1847 and 1863 (except Section 12 of the Act of 1863); Common or Commonable Lands; Exemption from Section 92 of the Lands Clauses Consolidation Act, 1845; Purchase of Lands by Compulsion, &c.; Further Money Powers; Confirmation of Lease or Grant from Lee Conservancy Board to Company; Repeal and Alteration of Section 144 of East London Waterworks Act, 1853, and certain Provisions of 10 Geo. IV, cap. 117; Agreements with Metropolitan Water Companies; Amendment of Acts.)

NOTICE is hereby given that application is intended to be made to Parliament in the ensuing Session, to be holden in the year 1897, by or on behalf of the East London Waterworks Company (hereinafter called "the Company"), for leave to bring in a Bill for the purposes, or some of the purposes, following (that is to say):—

1. To empower the Company to make and maintain the waterworks hereinafter described, or some or one of them, or some part or parts

thereof, respectively (that is to say):-

(1) A storage reservoir (to be called Reservoir No. 1), to be situate partly in the parishes of Tottenham and Edmonton, in the county of Middlesex, and partly in the parishes of Walthamstow and Chingford, in the county of Essex, and to be constructed partly in the fields or properties numbered 407 and 409 on the \$\frac{1}{2500}\$ Ordnance Map of the said parish of Tottenham, and partly in the fields or properties numbered 1531 and 1532 on the \$\frac{1}{2500}\$ Ordnance Map of the said parish of Edmonton, and partly in the fields or properties numbered 56, 57, 102, 103, 104, 105, 106, and 173 on the \$\frac{1}{2500}\$ Ordnance Map of the said parish of Walthamstow, and partly in the fields or properties numbered 456, 461, 462, and 463 on the \$\frac{1}{2500}\$ Ordnance Map of the said parish of Chingford, or in some or one of them, and intended to be formed by means of an embankment or retaining wall round the whole extent of such reservoir, bounded on the north-eastern, eastern, and south-eastern sides by Folly-lane, on the southern side by lands abutting on the Lee Navigation, and having an area of 103 acres, or thereabouts.

(2) A storage reservoir (to be called Reservoir No. 2), to be situate in the said parishes of Tottenham and Walthamstow, to be constructed partly in the fields or properties numbered 407, 408, 409, 602, 603, 604, 605, 743, 744, 745, and 746 on the \$\frac{1}{3}\frac{1}{3}\text{0}\$ Ordnance Map of the said parish of Tottenham, and partly in the fields or properties numbered 168, 169, 170, 171, 173, 228, 229, 230, 231, 232, 303, 304, 305, 306, 307, 399, 400, and

403 on the said \( \frac{1}{y \ 1} \) 0 ordnance Map of the said parish of Walthamstow, or in some or one of them, to be formed by means of an embankment or retaining wall round the whole extent of such reservoir, bounded on the eastern side by lands lying between Higham Hill Ferry and the High and Low Maynard Reservoirs of the Company, on the southern side by lands lying immediately north of Ferry-lane, and on the western side by the Tottenham Mill Lead, Stonebridge by the Tottenham Mill Lead, Stonebridge Lock, and lands abutting on the Lee Navigation, and on the northern side by the lands on which the intended Reservoir No. 1 will be constructed as aforesaid, and having an area of 115 acres, or thereabouts.

- (3) An aqueduct, conduit, or cut (to be called Cut No. 1), 920 yards, or thereabouts, in length, to be situate wholly in the said parish of Chingford, commencing at a point in the Chingford Mill Stream, 3 chains, or thereabouts, measured in a northerly direction from the bridge carrying the Angel-road over the said Chingford Mill Stream, and terminating at or near the northern side of the intended Reservoir No. 1.
- (4) An aqueduct, conduit, or cut (to be called Cut No. 2), being a diversion of the Ching Brook, 420 yards, or thereabouts, in length, to be situate wholly in the said parish of Chingford, commencing at or near the bridge carrying Folly-lane over the Ching Brook, and terminating in the intended Cut No. 3, at or near a point 6 chains, or thereabouts, southwards from the point of commencement thereof as hereinafter described.
- (5) An aqueduct, conduit, or cut (to be called Cut No. 3), being a diversion of the River Lee, 1,940 yards, or thereabouts, in length, commencing in the said parish of Chingford, in the bed of the River Lee, opposite the works of Messrs. Ridley, Whitley & Co., 34 chains, or thereabouts, measured along the course of the said river in a southerly direction from the bridge carrying the Angel-road over the said River Lee at Cook's Ferry, thence proceeding in a southerly direction, passing through the said parish of Edmonton, and terminating in the said River Lee, at or near Stonebridge Lock, in the said parish of Tottenham.

(6) An aqueduct, conduit, or cut (to be called Cut No. 4), 270 yards, or thereabouts, in length, to be situate partly in the said parish of Tottenham and partly in the said parish of Walthamstow, commencing at a point 14 chains, or thereabouts, north of Tottenham Mill, measured along the course of the Tottenham Mill Lead, thence proceeding in a southerly direction, and terminating in the bed of the River Lee at a point about 6 chains measured along the course of the said river in a northerly direction from Ferry Bridge carrying Ferry-lane over the said River Lee, in the parish of Walthamstow.

(7) A conduit or line or lines of pipes (to be called Conduit No. 5), 80 yards, or thereabouts, in length, to be situate wholly in the said parish of Tottenham, commencing at or near the southern end of the intended Reservoir No. 1, and terminating at or near the northern end of the intended Reservoir No. 2.

(8) A conduit or line or lines of pipes (to be called Conduit No. 6), 120 yards, or thereabouts, in length, to be situate wholly in the said parish of Walthamstow. com-
