Liverpool Corporation (No. 1).

(Amendment of Section 4 of Liverpool Corporation Loans Act, 1894, and creation of Corporation Stock of more than one class, and with different rates of interest; Grant of Land for Extension of Northern Hospital and Agreements with Authorities of Hospital; Borrowing and Rating Powers; Amendment of Acts).

NOTICE is hereby given that application is intended to be made to Parliament in the ensuing Session by the Mayor, Aldermen, and Citizens of the city of Liverpool (hereinafter called "the Corporation") for an Act for all or some of the following purposes (that is to say):—

To amend Section 4 of the Liverpool Corporation Loans Act, 1894, and to empower the Corporation, notwithstanding anything contained in that Act, to create and issue redeemable stock of different classes and bearing different rates of interest, and redeemable at different periods, and to extend and make applicable to stock to be created as aforesaid, such of the provisions of the said Act of 1894, with such modifications or variations (if any) as may be prescribed or provided for by the intended Act, and to make other provisions with reference to the matters aforesaid.

To empower the Corporation to grant and convey to the Trustees or other authorities of the Northern Hospital for the extension of, or other purposes connected with the said Hospital, upon and subject to such conditions and covenants as may be prescribed or provided for by the intended Act, the sites of Gibraltar-street and Gibraltar-place, and the reversions expectant upon the determination of the existing leases of a piece of land situate on the east side of Great Howard-street, the south side of Gibraltar-street, and the west side of Gibraltar-place, and to authorise the stopping up of and extinguishment of all rights of way over Gibraltar-street and Gibraltar-place, and the appropriation of the sites thereof to the purposes aforesaid.

To empower the Corporation to contribute to the funds of the said Hospital such sum or sums as may be prescribed or authorised by the intended Act, and to provide for the application thereof by the authorities of the said Hospital, and to empower the Corporation, out of moneys to be borrowed under the powers of the intended

Act, or in such other manner as may be prescribed or authorised by the intended Act, to pay to the credit of their Capital Personal Estate, or other fund of the Corporation, as may be prescribed by the intended Act, such sum or sums as they think fit, or as may be prescribed or authorised as aforesaid, as representing the value of the interest of the Corporation in the site or sites to be granted to the authorities of the said Hospital as aforesaid.

To empower the Corporation and the said authorities and all other necessary bodies and persons to enter into and carry into effect, alter, and rescind agreements and contracts, and to execute deeds and other instruments and perform all other acts which may be necessary, proper, or convenient for carrying into effect all or any of the objects aforesaid, and to confirm and give effect to or to alter, cancel, or annul any such agreements, contracts, deeds, or other instruments or acts which may have been or which may be entered into, executed, or performed prior to the passing of the intended Act.

To authorise the Corporation to borrow any moneys required for the purposes of or in connection with the intended Act upon the credit of rates and assessments which they are or may be authorised to make and levy, and if the Corporation shall think fit, upon the credit of the City Fund of the said city and of the estates and property of the Corporation, and to apply to such purposes any part of their corporate funds, and if thought fit to authorise and empower the Corporation to make, levy, and recover rates and assessments upon and from the owners and occupiers of property within the said city, for the purposes of the said intended Act, and to increase existing and authorised rates and assessments, and to grant exemptions from the payment of rates and assessments.

To vary or extinguish all existing rights and privileges which would or might in any way prevent or interfere with or delay the accomplishment of any of the objects of the intended Act, and to confer other rights and privileges.

To alter, extend, amend, enlarge, or repeal all or some of the provisions of the Act hereinbefore mentioned, and of the Liverpool Corporation Acts, 1890 and 1893, and any other Act or Acts relating to the Corporation or the city of Liverpool.
