landing stages, slips, wharves, buildings, and works, and to do all such things as they may deem necessary or expedient for the effectual working and maintenance of the said ferries or either of

To make applicable to the said ferries and the working of such ferries, or either of them, certain provisions of the Birkenhead Corporation Acts, 1881 and 1891, having reference to the existing ferries of the Corporation, and to provide that all bye-laws made by the Corporation having reference to ferries shall extend and apply to the ferries so to be purchased, and to be acquired as aforesaid, or either of them, and to the passengers and traffic conveyed thereon.

To make provision for the due maintenance of an efficient service of steamboats between the

New Ferry Pier and Liverpool.

To authorize the Corporation to build, purchase, maintain, alter, and repair steam or other boats, and to do all such things as may be necessary or convenient for the proper and efficient carrying on of the said New Ferry and Rock Ferry.

To authorize the Corporation to borrow for ferry purposes, such a further sum of money as shall be specified by the intended Act, by mortgages, stock, debentures, or other securities, and to enable the Corporation to apply their corporate funds, and any moneys which they are now authorized to raise, to such purposes.

To confer upon the Corporation all powers,
