

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction, consisting of a piece or parcel of land, comprising one thousand one hundred and ninety-four square yards, or thereabouts, which has been permanently secured to the vicarage of Christ Church, Ebbw Vale, in the county of Monmouth, and in the diocese of Llandaff, and in consideration also of a further benefaction of four hundred and three pounds sterling which has been paid to us in favour of the same vicarage, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said vicarage of Christ Church, Ebbw Vale, to meet the aforesaid benefactions, one capital sum of seven hundred pounds sterling, to be applicable towards defraying the cost of providing a parsonage or house of residence for the said vicarage, according to plans and a specification approved or to be approved by us, such capital sum, or the balance thereof unapplied to such purpose, to remain in the meantime in our hands at interest after the rate of two pounds and ten shillings per centum per annum, and such interest to be paid to the Incumbent for the time being of the said vicarage of Christ Church, Ebbw Vale.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent of the consolidated chapelry and benefice (hereinafter called the benefice) of Saint Michael at Bowes, Southgate, in the county of Middlesex, and in the diocese of London, and to his successors, Incumbents of the same benefice, one yearly sum or stipend of fifty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the nineteenth day of January, in the year one thousand eight hundred and ninety-seven, and to be receivable in equal half-yearly portions, on the first day of May and on the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient, in our opinion, to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said benefice, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her Majesty, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent for the time being of the vicarage of Saint Mark, South Shields, in the county of Durham, and in the diocese of Durham, one yearly sum or stipend of one hundred and twenty pounds,

such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the thirty-first day of December, in the year one thousand eight hundred and ninety-six, and to be receivable in four equal portions, on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year: Provided always, that the annual sum or stipend so granted by us to the Incumbent of the said vicarage of Saint Mark, South Shields, shall be paid only upon the production to us, on or after each of the said lastly-mentioned days in each and every year, of a certificate under the hand of the Bishop of the said diocese of Durham, that an Assistant-Curate, duly licensed by such Bishop, has been employed within the parish of Saint Mark, South Shields aforesaid, during the quarter of the year then ended, and is in receipt of a salary after a rate of not less than one hundred and twenty pounds per annum: Provided also, that such yearly sum or stipend shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting the said vicarage and parish of Saint Mark, South Shields.
