GENERAL ORDER of the Local Government Board : Apprenticeship of Pauper Children : Amending Orders :—

King's Norton Union.

To the Guardians of the Poor of the King's Norton Union ;—

And to all others whom it may concern.

WHEREAS by certain General and other Orders, the Poor Law Commissioners, the Poor Law Board, and We, the Local Government Board, prescribed Regulations to be observed by the Guardians of the said Union with regard to the Apprenticeship of pauper children ;

And whereas it is expedient that, so far as regards the said Union, further provision should be made as hereinafter mentioned :

Now therefore, in pursuance of the powers given to Us by the Statutes in that behalf, We hereby alter the said Orders so far as regards the said Union, so as to provide that We may assent, in any case where it may seem to Us necessary or expedient, to a departure from any of the Regulations contained in the said Orders with regard to the Apprenticeship of pauper children.

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 13TH FEBRUARY 1897.)

SWINE-FEVER (MOVEMENT FROM IRELAND) TEMPORARY ORDER OF 1897.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

*Swine-Fever (Movement from Ireland) Temporary Order of 1894 continued until 31st May 1897.*

1. The Swine-Fever (Movement from Ireland) Temporary Order of 1894 shall be read and have effect as if the thirty-first day of May, one thousand eight hundred and ninety-seven were substituted for the thirtieth day of November, one thousand eight hundred and ninety-four in Article 1 of that Order, as the date from and

immediately after which that Order shall cease to operate, and the operation of that Order which was continued by subsequent Orders is hereby further continued accordingly.

*Existing Regulations of Local Authority.*

2. Any Regulation made by a Local Authority under the Swine-Fever (Movement from Ireland) Temporary Order of 1894 as continued by subsequent Orders and in force on the twenty-eighth day of February, one thousand eight hundred and ninety-seven, shall, unless altered or revoked by such Local Authority, remain in force until the thirty-first day of May, one thousand eight hundred and ninety-seven.

*Short Title.*

3. This Order may be cited as the SWINE-FEVER (MOVEMENT FROM IRELAND) TEMPORARY ORDER OF 1897.

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 13TH FEBRUARY 1897.)

(SWINE-FEVER INFECTED AREA.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

1. The Order described in the Schedule to this Order is hereby from and after the commencement of this Order revoked : Provided that such revocation shall not invalidate or make unlawful anything done under the Swine-Fever (Infected Areas) Order of 1896 and the Order described in the Schedule to this Order before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, those Orders before the commencement of this Order.

2. This Order shall come into operation on the seventeenth day of February, one thousand eight hundred and ninety-seven.
