

Approximate position, lat. 20° 53' 35" N., long. 37° 9' 25" E.

(3.) *Kamarán Bay—Beacons at South Entrance.*

a. A masonry beacon, square in section, and surmounted by a pole and cage, has been erected close to the cable house at Yemmen, south end of Kamarán Island; in approximately, on chart No. 143, lat. 15° 16' 40" N., long. 42° 34' 10" E.

b. A pole beacon, surmounted by a cage, has been erected on the north-west extreme of Ras el Bayádh, the point on the east side of the entrance, opposite Yemmen.

(4.) *Okbán—Reef off South Point.*

A fringing reef extends for some distance from the south end of Okbán Island.

This is now shown on the charts to a distance of one mile from the island.

Approximate position, Okbán south point, lat. 15° 27½' N., long. 42° 23½' E.

*Ile De Groix—Alteration in Pen Men Light.*

WITH reference to Notices to Mariners Nos. 82 and 182 of 1897:—

The French Government has given further notice that, on 15th May, 1897, the light at the north-west end of Ile de Groix (Pen Men) will be altered from a fixed white light to a cata-dioptric group flashing white light with a period of about
