THE following Correspondence has been received from the Foreign Office, enclosing Despatches relative to the Recent Niger Sudan Campaign :—

Foreign Office,

May 14, 1897.

SIR,
 I AM directed by the Marquess of Salisbury to transmit to you a report by Sir George Goldie on the recent campaign undertaken by the Royal Niger Company, including the military report of Major Arnold, Commandant of the Royal Niger Constabulary.

I am to request that in laying these papers before the Marquess of Lansdowne you will express the hope of the Secretary of State for Foreign Affairs that the services of the Officers specially mentioned may be found worthy of exceptional recognition and that all engaged may be given the West African medal.

Lord Salisbury proposes to express to the Niger Company the high appreciation of Her Majesty's Government of the manner in which the campaign was organized and carried out.
