Especially do we regard as a subject of congratulation the increased number of Indian and Colonial students secured to us by the consolidation of the Empire, and we desire to tender our acknowledgments for the salutary legislation which, in the interval since we addressed Your Majesty, has opened a wide career of usefulness for themselves and the other Universities of Scotland. In the domestic sorrows and joys which have been Your Majesty's portion during the last ten years, the University of Edinburgh has felt profound sympathy. Your Majesty has long reigned in the hearts of Your people, and, in common with countless thousands, we pray that for years to come Your Majesty may be spared to rule over us, and that these years may be fraught not only with continued national prosperity, but with an increasing measure of personal and domestic happiness. .
