Approximate position (b), lat. 63° 26' 35" N., long. 10° 24' 35" E.

WITH reference to Notice to Mariners No. 551 of 1897:—

The Norwegian Government has given further notice that, on 1st November, 1897, Sondre Botten Light would be exhibited:—

1. Sondre Botten Light is an occulting light, elevated 14 feet above high water, showing the following sectors:—white from S. 39° W. (westward of North nes), through south, to S. 9° E.; red from S. 9° E. (eastward of the Vingens) through east, to N. 77° E.; white from N. 77° E. to N. 20° E. (westward of Seljestokken); and obscured from other directions.

It will be exhibited annually from 1st August to 15th May.

Approximate position, lat. 61° 43' 25" N., long. 4° 58' 30" E.

2 Also that the sector of red light, visible from S. 48° E. to S. 25° E., previously shown from Hellevik Lighthouse, has been replaced by a sector of flashing white light.

Approximate position, lat. 62° 38' 10" N., long. 6° 10' 50" E.

WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction consisting of a piece or parcel of land comprising one thousand five hundred and ninety square yards or thereabouts, which has been permanently secured to the vicarage of Saint Mary, Ambleside, in the
