Mag Majesty's High Court of Chancery bearing date the fourth day of December in the year one thousand eight hundred and fifty-eight approving a scheme for the regulation and management of the 'Bolton Lectureship Charity Estate' and of certain Orders of the Charity Commissioners for England and Wales bearing date respectively the ninth day of May in the year one thousand eight hundred and seventy-one and the twelfth day of August in the year one thousand eight hundred and seventy-three amending the said Order and Decree of the fourth day of December in the year one thousand eight hundred and fifty-eight a clear annual sum of one hundred and fifty pounds has been provided out of the revenues of the said estate and is available for and towards the endowment of the district hereinafter recommended to be constituted and for and towards 'the maintenance of the minister thereof, so soon as such minister shall have been appointed and licensed thereto and of his successors ministers of the same district and when the same district shall have become a new parish then to the minister or incumbent of such new parish.

"And whereas the said annual sum of one hundred and fifty pounds is available as aforesaid and has been so provided upon the understanding that (such arrangement appearing to us to be expedient) the right of patronage of the said district hereinafter recommended to be constituted and of the nomination of the minister thereof should be assigned in the manner hereinafter mentioned.

"And whereas the Trustees of the said Bolton Lectureship Charity Estate have nominated to us as the persons to whom they the said Trustees desire that the right of patronage of the said pro-posed, district should be assigned the Right Reverend James Bishop of the said diocese of Manchester and his successors Bishops of the same diocese for ever for the first and each and every alternate turn of appointment and themselves the said Trustees and their successors for the second and each and every other alternate turn of

appointment.

"Now therefore with the consent of the said James, Bishop of the said diocese of Manchester (in testimony whereof he has signed and scaled this scheme) we the said Ecclesiastical Commissioners humbly recommend and propose that all those contiguous portions of the said new parish of Saint Mark Bolton-le-Moors and of the said district chapelry of Saint George the Martyr, Daubhill which are described in the Schedule hereunder written and which are delineated and set forth upon the map or plan hereunto annexed shall upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme become and be constituted a separate district for spiritual purposes and that the same shall be named 'The District of Saint Philip, Bolton-le-Moors.'

"And we further recommend and propose that the patronage of the said proposed district or new parish and the right of nomination of the minister or incumbent thereof for the first and thereafter every alternate turn of presentation or nomination shall without any assurance in the law other than this scheme and any duly gazetted Order of Your Majesty in Council ratifying the same and upon and from the day of the date of the publication of such Order in the London Gazette as aforesaid be assigned to and be absolutely vested in and shall and may from time to time be exercised by the said James Bishop of the said diocese of Manchester and his successors Bishops of the same diocese for ever and that such patronage and

right of nomination aforesaid shall for the second and every subsequent alternate turn of presentation or nomination be in like manner assigned to and be absolutely vested in and be from time to time exercised by the said Trustees of the Bolton Lectureship Charity Estate aforesaid and their successors for the time being.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of either of them or of any other Act or Acts of Parliament.

" The SCHEDULE to which the foregoing Scheme has reference.

"The District of Saint Philip Bolton le-Moors,

comprising:

"1. All that portion of the new parish (sometime district) of Saint Mark Bolton-le-Moors within the original limits of the ancient parish of Bolton-le-Moors in the county of Lancaster and in the diocese of Manchester which is bounded on the south by the new parish of Saint Michael Great Lever in the county and diocese aforesaid, upon the south-west by the district chapelry of Saint George the Martyr Daubhill in the said county and diocese upon the north-west by that part of the said last-named cure (including the hereinafter described portion thereof) which is within the original limits of the ancient parish of Bolton-le-Moors and upon the remaining sides, that is to say, upon the north-east and upon the south-east by an imaginary line commencing at a point in the middle of High-street opposite to the middle of the disused goods line or coal siding of the London and North Western Railway at which point the boundaries of the said district chapelry of Saint George the Martyr Daubhill of the new parish of Emmanuel, Bolton-le-Moors in the county and diocese aforesaid and of the new parish of Saint Mark, Bolton-le-Moors aforesaid all meet and extending thence south-eastward along the middle of High-street aforesaid for a distance of twelve and a half chains or thereabouts to the point where it passes over the Bolton and Kenyon line of the said London and North Western Railway and extending thence southwestward along the middle of the said line of railway for a distance of seventeen chains or thereabouts to the boundary at Tanner Hole Brook which divides the said new parish of Saint Mark Bolton-le-Moors from the new parish of Saint Michael, Great Lever aforesaid.

(2.) And also all that contiguous portion of the said district chapelry of Saint George the Martyr, Daubhill (within the original limits the ancient parish of Bolton-le-Moors as aforesaid) which is bounded on the southeast by the hereinafter described portion of the said new parish of Saint Mark, Bolton-le-Moors on the north-east by the new parish of Emmanuel, Bolton-le-Moors aforesaid on the north-west partly by the last-named cure and partly by the new parish of Saint Saviour Boltonle-Moors in the county and diocese aforesaid and upon the remaining sides that is to say upon the south-west by an imaginary line commencing upon the boundary which divides the last-named cure from the District Chapelry of Saint George the Martyr, Daubhill aforesaid at the point where Derby-street is joined by Goldsmith-street and thence south-eastward along the extending middle of the last-named street for a distance of six and a quarter chains or thereabouts to the boundary at the junction of the same street with Back Auburn-street which boundary divides the
