

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 1ST DECEMBER 1897.)

(SWINE-FEVER INFECTED AREA.)

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. The Order described in the Schedule to this Order is hereby from and after the commencement of this Order revoked: Provided that such revocation shall not invalidate or make unlawful anything done under the Swine-Fever (Infected Areas) Order of 1896 and the Order described

in the Schedule to this Order before the commencement of this Order, or interfere with the institution or prosecution of any proceeding in respect of any offence committed against, or any penalty incurred under, those Orders before the commencement of this Order.

2. This Order shall come into operation on the fourth day of December, one thousand eight hundred and ninety-seven.

NOTICES TO MARINERS.

No. 729.—YANG TSE KIANG ENTRANCE.

Alteration in Position of Fairway Buoy.

THE Chinese Government has given notice, that in consequence of the recent movement of the South-east Spit, Tung Sha Banks, to the south-westward, the fairway buoy (bell, red and black horizontal stripes) at the entrance of the South Channel of the Yang tse Kiang has been moved one mile to the southward, and is now moored with Tung Sha Light-vessel bearing N. 54° W., or approximately in lat. 31° 30' 3" N., long. 122° 9' 0" E.

No. 730.—NORWAY.

Exhibition of Lights.

WITH reference to Notices to Mariners Nos. 159 and 551 of 1897:—

The Norwegian Government has given further notice that on 15th November, 1897, the under-mentioned lantern lights would be exhibited:—

1. Angersholmen Light is an occulting light, elevated 23 feet above high water, showing the following sectors:—white from S. 67° W. (northward of Tiuruhovdet) to S. 54° W.; red from

S. 54° W. to S. 31° W. (over dangers); white from S. 31° W., through south and east, to N. 36° E. (westward of Sleipnæs Point); and obscured from other directions.

Approximate position, lat. 66° 45' 45" N., long. 13° 16' 10" E.

2. Rangundöen Light, on the north-east point of Rangundo, is an occulting light, elevated 24 feet above high water, showing the following sectors:—white from S. 10° W. (eastward of Gierö) to S. 20° W.; red from S. 20° W. (westward of Langmand Skerries) to S. 37° W.; white from S. 37° W., through west and north, to N. 11° E.; and obscured from other directions.

Approximate position, lat. 66° 34' 30" N., long. 13° 6' 0" E.

3. Anklakken Light, on the summit of the western Anklakhaug, is an occulting light, elevated 143 feet above high water, showing the following sectors:—white from S. 30° W. (eastward of Hestmandö) to S. 71° W.; red from S. 71° W. (northward of Vikingen), through west, to N. 54° W.; white from N. 54° W. to N. 53° W.; green from N. 53° W. (northward of Smaaskjær-tarren), through north, to N. 40° E. (westward of Dragskier); white from N. 40° E. to N. 49° E.; red from N. 49° E. to N. 52° E. (over dangers); white from N. 52° E. to N. 59° E.; and obscured from other directions.

Approximate position, lat. 66° 30' 35" N., long. 12° 53' 20" E.

4. Bonetskier Light is an occulting light, elevated 21 feet above high water, showing the following sectors:—white from S. 12° E., through south, to S. 5° W.; red from S. 5° W. (westward
