Intended Lights on Dungeness Point.

THE Chilian Government has given notice that, about the middle of the year 1898, the undermentioned light will be exhibited from a lighthouse now in course of crection on Dungeness Point, northern side of eastern entrance to Magellan Strait :-

1. Dungeness principal light will be a first order, flashing white light every minute, thus :light, eight seconds; eclipse, fifty-two seconds; elevated 88 feet above the sea, and visible in clear weather from a distance of 15 miles.

The lighthouse will be a cylindrical, iron tower, standing on a concrete base, with the keeper's dwelling adjoining.

Approximate position, lat. 52° 23' 55" S., long. 68° 25' 40" W.

2. Also, it is proposed to exhibit from the same tower, and beneath the principal light, a fixed white light, showing over the Nassau Rock.
