IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of the Soke of Peterborough, I hereby make the following Orders :

I. "The Wild Birds Protection Act, 1880," shall apply within the Administrative County of the Soke of Peterborough to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act :-

Eagle (every species), Buzzard (every species), Hawk (Hobby, Merlin, Kestrel, Hen Harriers), Shrike, Flycatcher, Hedgesparrow, Redbreast, Redstart or Firetail, Stonechat, Whinchat, Warbler (Reed Warbler, Sedge Warbler, Grasshopper Warbler, Garden Warbler, Black Cap, Chiffchaff), Wren (Wood Wren, Willow Wren, Golden-crested Wren) Treecreeper, Nuthatch, Wagtail (Pied, Grey, and Yellow), Swallow, Martin, Swift, Wryneck or Cuckoo's Mate, Landrail or Corncrake, Heron.

2. The time during which the killing and taking of Wild Birds is prohibited within the Administrative County of the Soke of Peterborough shall be varied so as to be from the 15th day of March to the 1st day of September in each year, and so far as concerns the Heron the close time shall be further varied so as to be from the 1st day of February to the 1st day of September in each year.

3. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the Administrative County of the Soke of Peterborough :-

Buzzard, Honey Buzzard, Hobby, Merlin, Hen Harrier, Nuthatch, Shrike, Oriole, Nightjar or Fern Owl, Kingfisher, Wryneck or Cuckoo's Mate, Sandpiper or Summer Snipe, Redshank, Landrail or Corncrake, Kestrel, Owl (every species), Goldfinch, Woodpecker, Nightingale.

4. The Order of the 8th December, 1882, is hereby repealed.
