be withheld until a report has been forwarded to, and instructions issued by, the Department.

7. Clearance will be issued in all other cases in compliance with the provisions of law.

8. Collectors in doubt in any particular application for clearance will telegraph promptly the facts to the Department and withhold clearance until instructed.

9. The Department declines to give general advice to masters and owners of vessels, shippers, consignees, etc., etc. Any specific case requiring action by the Department must be submitted by those concerned to the proper officer of the customs, who, if in doubt, will communicate with the Department and await instructions before taking action.
