To the Treasurer of the Guardians of the Poor of the said Union ;-

And to all others whom it may concern.

WHEREAS by a General Order dated the 7th day of Apr.l, 1857, addressed to the Guardians of the Poor of the said Clun Union, amongst others, the Poor Law Board directed that all orders which might be drawn by such Guardians of the Poor upon their Treasurer for a sum greater than five pounds should, from and after the 24th day of June, 1857, be in the form prescribed by the said General Order;

And whereas it is expedient that further provision in the matter should be made as hereinafter mentioned :

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby order and direct as follows :--

Notwithstanding anything contained in the said General Order dated the seventh day of April, one thousand eight hundred and fifty-seven, the Guardians of the Poor of the said Clun Union may, if they think fit, pay any sum by an order drawn upon their Treasurer in the form contained in the schedule hereto, which order shall be signed by the presiding Chairman and two other Guardians at a meeting, and shall be countersigned by the Clerk to the Guardians.

And We do hereby order the Treasurer of the said Guardians to pay, out of the moneys for the time being in his hands belonging to them, all orders for money which shall be drawn upon him in the said form contained in the schedule to this Order, when the same shall be presented at his house or usual place of business, and within the usual hours of business.
