All that space in the Southampton Docks, within the borough of Southampton, the property of the Southampton Docks Company, being about fifty feet by twenty feet of the southern portion of the shed formerly approved by Order of the Privy Council as a foreign animals quarantine station, and which shed is situate at or near the southwest corner of the Inner Dock.

ORDER OF THE BOARD OF AGRICULTURE.

(DATED 12TH SEPTEMBER 1898.)

SWINE-FEVER (MOVEMENT) TEMPO-RARY AMENDMENT ORDER OF 1898.

THE Board of Agriculture, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 and 1896, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Movement of Swine on a Highway between different parts of a Farm in the same Occupation.

- 1. Notwithstanding anything in the Swine-Fever (Movement) Order of 1898, swine may be moved by the nearest available route along or across a highway or thoroughfare in a Swine Movement District, from one part of a farm to another part of the same farm, being in the same occupation, and for such movement the Declaration required by Article 3 of that Order shall not be required.
 - Provided-
 - (a.) that the swine to be moved are not affected with swine-fever; and
 - (b.) that the swine are not in a Swine-Fever Infected Place, and that the movement of such swine is not prohibited by Notice of an Inspector of a Local Authority or of the Board given under any Order of the Board.
