THE Queen has been pleased to grant unto Arthur Chichester Burnard, otherwise Arthur Chichester Chichester, Clerk, Rector of Badlesmere, in the county of Kent, and Bachelor of Arts of the University of Oxford, Her Royal licence

and authority that he and his issue may in compliance with a clause contained in the last will and testament of John Hody William Chichester, late of Stoke House, in the parish of Stoke St. Michael, otherwise Stoke Lane, in the county of Somerset, Bachelor of Arts of the said University, deceased, and in compliance with a Deed of Indenture bearing date the 29th day of September, 1863, made between John Langford Burnard, late of Crewkerne, in the county of Somerset, and Charlotte Jane, his wife, and John Chichester Burnard, their eldest son, of the first part, and others therein named of the second and third parts, take and henceforth use the surname of Chichester in lieu of that of Burnard, and that he and they may bear the arms of Chichester quarterly with those of Burnard; the said arms being first duly exemplified according to the laws of arms, and recorded in the College of Arms, otherwise the said Royal licence and permission to be void and of none effect:

And to command that the said Royal concession and declaration be recorded in Her Majesty's said College of Arms.
