WE, the undersigned, Lords Commissioners of Her Majesty's Treasury of the United Kingdom of Great Britain and Ireland, do hereby, under the authority of "The Customs Consolidation Act, 1876," appoint Stockton, on and after the 10th day of November, 1898, to continue and be a Port in that part of the United Kingdom called England, and do hereby declare that the limits of the said Port shall commence at a point on the south side of the River Tees, about three hundred and thirty yards to the south or south-west of the old quay wall at the south-west end of the public ferry landing at Newport, in the borough of Middlesbrough, in the county of York, such point being the westerly boundary of the borough and of the port of Middlesbrough, thence west of an imaginary line drawn from such point at right angles from the southern bank of the river to the northern bank, and shall include the whole of the River Tees west of such line.

And we, the said Lords Commissioners of Her Majesty's Treasury, do hereby, on and after the day and year above-mentioned, annul all former limits of the Port of Stockton. Whitehall, Treasury Chambers, the 9th day
