

In Parliament.—Session 1899.

London Water (Aqueducts and Works).

(Construction of Storage and Service Reservoir at Borehamwood, Hertfordshire; Construction of Aqueduct from proposed Reservoir on the River Yrfon in Brecknockshire to proposed Reservoir at Borehamwood; Filter-beds near Edgware and Hendon, Middlesex; Other Aqueducts and Works; Compulsory purchase of Lands; General and Incidental Powers; Financial Provisions; Raising of Money by Creation of Stock; Charge on Water Rates and County Rate.)

THE London County Council (in this Notice called "the Council") intend to apply to Parliament in the ensuing Session for leave to bring in a Bill for the purposes or some of the purposes hereinafter mentioned, namely:—

To empower the Council to make and maintain the Reservoirs Aqueducts Waterworks and Works hereinafter described or some of them (that is to say):—

Work No. 1 (Borehamwood Reservoir).—A Service Reservoir (hereinafter called "the Borehamwood Reservoir") to be situate in the County of Herts on lands partly in the Parish of Aldenham, partly in the Parish of Elstree, and partly in the Parishes of Ridge and Shenley; and to be formed by means of embankments as hereinafter described:—

The said Reservoir is intended to be situate on lands lying between the Midland Railway and the main road leading from Elstree to Shenley and to be comprised within embankments to be formed as hereinafter described:—

An Embankment (No. 1) wholly in the said Parish of Aldenham commencing in a field numbered 220 on the $\frac{1}{2500}$ Ordnance map of that Parish near "Tilehouse Farm" about 5 chains north-eastward of the centre of the foot-bridge crossing over the Midland Railway and leading to that farm, and terminating about 5 chains north-eastward of a barn called High Gardens in a field No. 167 on the said Ordnance map;

An Embankment (No. 2) commencing in the Parish of Elstree to the southward of "Tilehouse Farm" in a field numbered 34 on the said Ordnance map of that Parish at a point about 2 chains eastward of the road leading from Borehamwood to Radlett about 18 chains from the junction of the said road with Shenley Road at Borehamwood and to terminate in the parish of Ridge at a point about 3 chains to the westward of the said road from Elstree to Shenley and 25 chains southward of Green Street Farm in the field No. 82 on the said Ordnance map of the said parish;

Work No. 2 (Main Aqueduct).—An Aqueduct Conduit or Line of Pipes to commence at the dam or embankment of a Reservoir proposed to be made on the River Yrfon in the County of Brecknock to terminate at the Borehamwood Reservoir in the County of Herts;

The said Main Aqueduct is intended to commence in the Parish of Llanynis in the Rural District of Builth and County of Brecknock in a plantation or field numbered 146 on the $\frac{1}{2500}$ Ordnance map of that Parish at a point 20 chains or thereabouts west of the junction of the private road leading to the farm house of Cefn-llys-gwynne with the public road leading from Builth to Llanwrtyd and about 1 chain south of the northern boundary fence of the said plantation or field numbered 146 and to terminate at a point in the Parish of Aldenham in the County of Herts, in a field numbered 173 on the $\frac{1}{2500}$ Ordnance Map of that Parish 12

chains or thereabouts east of the barn called High Gardens on the said map;

The said Aqueduct will pass through or into the several Parishes hereinafter described or some of them viz.:—

In the County of Gloucester.—The Parishes and places of East Dean, Longhope, Mitcheldean, Newent, Taynton, Huntly, Tibborton, Churcham, Hartpury, Maisemore, Sandhurst, Longford, Wooton-St.-Mary (Without), Barnwood, Hucclecote, Churchdown, Brockworth, Bageworth, Great Shurdington, Coberley, Dowdeswell, Withington, Chedworth, Rendcomb, Eastington, Aldsworth, Sherborne and Great Barrington; the Parish and Urban District of Charlton Kings; the Parish of Bulley in the Rural District of East Dean and united Parishes; the Parish of Rudford in the Rural District of Newent; the Parishes of Over Higham and Linton, Lassington, Twiggworth, in the Rural District of Gloucester; the Parishes of Leckhampton and Cowley in the Rural District of Cheltenham; the Parish of Colesborne in the Rural District of Cirencester; the Parishes of Compton Abdale, Yanworth, Stowell, Coln St. Denys, Hampnett, Coln St. Rogers, Farmington, Windrush and Little Barrington in the Rural District of Northleach;

In the County of Oxford.—The Parishes and places of Fulbrooke, Milton-under-Wychwood, Shipton-under-Wychwood, Ascot-under-Wychwood, Charlbury, Spelsbury, Enstone, Steeple Barton, Steeple Aston, Lower Heyford, Upper Heyford, Middleton Stoney, Fritwell, Stoke Lyne, and Hethe; the Parishes of Tainton, and Upton and Signet in the Rural District of Witney; the Parishes of Kiddington-with-Asterleigh, Wescot Barton, Glympton and Rousham in the Rural District of Woodstock the Parish of Sandford in the Rural District of Culham; the Parishes of Ardley, Somerton, Bucknell, Hardwick, Tusmore, Cottesford, Mixbury, Shelswell, Finmere and Newton Purcell in the Rural District of Bicester;

In the County of Buckingham.—The Parishes of Tingewick, Padbury, Adstock, Thornborough, Great Horwood, Little Horwood, Winslow, Mursley, Swanbourne, Stewkley, Drayton Parslow, Cublington, Whitchurch, Wingrave, Wing, Mentmore, Cheddington, Ivinghoe, Pitstone, Edlesborough and Marsworth; the Parish and Borough of Buckingham; the Parishes of Barton Harthorn, Chet-
