four, become a new parish of the character contemplated by that Act, and by the Act of the sixth and seventh years of Your Majesty chapter thirty-seven, and by the above-mentioned Act of the thirty-second and thirty-third years of Your Majesty chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Saint Mark Newport should be altered in the manner herein-

after mentioned.

" Now therefore with the consent of the Right Reverend Richard Bishop of the said diocese of Llandaff (in testimony whereof he has signed and sealed this scheme or representation) we, the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation the boundaries of the said new parish of Saint Mark Newport shall be altered so that there shall be annexed to the same new parish, all that portion of the said parish of Saint Woolos (Newport) which is described in the First Schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured green, and that from and after the day of the same date and without any assurance in law other than such duly gazetted Order the said portion of the said parish of Saint Woolos (Newport) shall be included within and shall become and be and form part of the said new parish of Saint Mark Newport and also that from and after the day of the same date of publication in the London Gazette as aforesaid the boundaries of the said new parish of Saint Mark Newport shall be further altered so that there shall be dissevered therefrom all that portion thereof which is described in the Second Schedule hereunder written and is delineated and set forth upon the said map or plan hereunto annexed and is thereon coloured pink and that from and after the day of the same date and without any assurance in law other than such duly gazetted Order the said portion of the said new parish of Saint Mark Newport so to be dissevered from such new parish shall be restored to and included within and shall again become and be and form part of the said parish of Saint Woolos (Newport).

" And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any other Act of

Parliament.

" The SCHEDULES to which the foregoing Scheme or Representation has reference. " THE FIRST SCHEDULE.

"The territory to be annexed to the new parish of Saint Mark Newport in the county of Monmouth and in the diocese of Llandaff being :-

"All that portion of the parish of Saint Woolos (Newport) in the county and diocese aforesaid which is bounded on the south by the district of Saint John the Baptist Newport in the same county and diocese upon the north-west, upon the north-east and upon part of the south-east by the new parish of Saint Mark Newport aforesaid, and upon the remaining part of the south-east by an imaginary line commencing upon the boundary which divides the last-named new parish from the parish of Saint Woolos (Newport) aforesaid at the point where the road called or known as Clyffardsouth-westward along the middle of the lastmentioned road for a distance of four and a half chains or thereabouts to its junction with Spencerroad upon the boundary which divides the said parish of Saint Woolos (Newport) from the district of Saint John the Baptist Newport afore-

"THE SECOND SCHEDULE.

"The territory to be dissevered from the said new parish of Saint Mark Newport and to be restored to the parish of Saint Woolos (Newport)

aforesaid being :-

"All that portion of the said new parish of Saint Mark, Newport, which is bounded upon the south upon the east and upon the north by the parish of Saint Woolos (Newport) aforesaid and upon the remaining side that is to say upon the west, by an imaginary line commencing upon the boundary which divides the said parish of Saint Woolos (Newport) from the new parish of Saint Mark, Newport aforesaid at a point at the eastern end of the bridge over the line of the South Wales division of the Great Western Railway which bridge connects Clytha Park-road with Bridgestreet the said point being opposite to the northern end of the footway or roadway leading to the road called or known as Albert-terrace and extending thence southward for a distance of ten and a half chains or thereabouts to and along the middle of the said footway or roadway and along the middle of the road called or known as Albert-terrace as aforesaid to the junction of the last-named road with the road called or known as Clyffard-crescent aforesaid upon the boundary which divides the said new parish of Saint Mark Newport from the parish of Saint Woolos (Newport) aforesaid."

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have. been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Llandaff.
