Rome, Sept. 15.

THE Pope, though he is not yet perfectly recovered of his late Indisposition, does not forbear giving Audiences to the Cardinals and Foreign Ministers. The Count de Piceolomini, who is newly arrived here from Vienna, had his on Monday last, and gave the Pope a full account of the late Victory in Hungary, Presenting at the same time the Grand Viliers's Standard taken in that Action, which is like that the King of Poland sent him after the raising the Siege of Vienna. On Tuesday *Te Deum* was sung in the Chapel of the Palace, at which the College of Cardinals was present, and at night there were Publick Rejoycings and Illuminations through the whole City. On Wednesday the Duke de Chaulnes, Ambassador of France, parted from hence for Legborne, where he intends to Embark with the Cardinal of Bouillon, in order to their return home. Cardinal Camus is gone before, and Cardinal Bonzi will follow in few days. We hear, that the Pestilentious Dittemper that lately raged in some Provinces of the Kingdom of Naples, is now quite ceased.

Venice, Sept. 21. His Excellency Sir William Trumbull, Ambassador from Their Majesties of Great-Britain at the Ottoman Port, is arrived here in the Ship *Asia* from Corfeu, where he left the Man of War that brought him from Smyrna, and from hence he will proceed by Land on his return for England. The Advices from the Levant say, that Signior *De'fino* continues to cruize with a Squadron of Venetian Men of War in the Archipelago; That the Captain-General *Mocenigo* was come with the Gallies to Andros; And that the Gallies of *Multa* are gone home.

Lemberg, Sept. 6. The King of Poland is marched with an Army of 24000 Men into Moldavia, and by our last advice was advanced to the River *Prut*, where he encamped on the 3d, having sent a Detachment to attack a great Body of Turks and Tartars that were conducting a Convoy of Provisions to Caminic. In the mean time the Castellian of *Colin* is marched with 4000 Cossacks towards *Bodjisc*.

Vienna, Sept. 27. The last Letters from Hungary do all say, that Prince *Lewis* of Baden had

passed the *Theisse* with the Imperial Army near *Zelucke*, and that he continued his march towards *Great Waradin* with a resolution to besiege that place, which is said to be in no condition to make any long defence. The Emperor has given the Regiment, vacant by the death of Count *Chizzola*, to his Lieutenant Colonel *Labaschecky*, who was lately a Prisoner at *Begrade*, and that of General *Dunewait* to the Count *d. Truboch*.

From the Camp before Limerick on Clare side, Sept. 24. On the 22th instant the General passed the *Shannon* very early in the Morning with a strong Detachment of Horse and Dragoons, 10 Regiments of Foot, and 14 Pieces of Cannon, the rest of the Army remaining under the Command of the Duke of *Wintzenberg*, for the Security of our Works on the other side. About Noon our Troops drew up before the English Town, the Enemy playing upon them all the while from the Castle and several Towers, both with great and small Shot. About 4 a clock the General ordered a Detachment to attack the Fort near *Thomond Bridge*; The Enemy sent two great Detachements out of the Town to support those that defended it; but our Men went on with that Courage and Vigour, that they beat the Enemy, notwithstanding this Reinforcement, out of the Fort, and parted them over the Bridge to the Town, upon which the Governor fearing we should have enter'd it with them, caused the Bridge to be drawn up, and thereby left those that were without exposed to the fury of our Men, who killed about 600, and took 200 Prisoners, among whom were 3 Colonels, and about 20 other Officers; we took likewise 3 Pieces of Cannon, and 5 Colours; And on our side had about 200 killed and wounded. Soon after this action, Colonel *Wabsp*, looking out of a Tower, called to Lieutenant-General *Sourinners*, and desired Leave to come and speak with him, which was granted; After some Discourse, he desired the same Liberty for *Sarsfield* to speak with Major-General *Rochy*, which was likewise allowed him; Accordingly *Sarsfield* came out, and both discoursed about Terms for the Surrender of the Place; Towards Evening they returned into the Town, where there was that Night a great disorder among the Garrison, who had like to have insulted the House of the French Governor.

vernor, against whom they were mightily incensed for shutting the Gate against the Irish, and suffering them to be cut off as they were. The next day *Sarsfield* and *Walop* came out again, and desired 3 days Truce, and that they might send to Colonel *Sheldon*, who lay with about 1500 Horse at *Six-miles-bridge*, to the end they might be included in the Capitulation, which was granted them. Some other Persons were likewise sent out to carry on the Treaty, which still continues; and tis not doubted but all Matters will be adjusted, and that in 2 or 3 days we shall be Masters of the Town. We are now possessed of all their Works and Retrenchments on this side the Water, and particularly of the Fort which commands *Thomond Bridge*.

Dublin, Sept. 29. By an Express from the Camp, which arrived here yesterday morning, we have an account, That on the 22th our Troops attack'd and made themselves Masters of the Fort near *Thomond Bridge*, having killed about 600 of the Enemy, and taken 300 Prisoners, that thereupon the Garrison beat a Parley all round the Town; That *Sarsfield* and *Walop* came out to Treat, and Hostages were exchanged; Those from the Enemy being the Lords *Westmeath, Iovagh, Trimblestown, and Lowth*; and from us the Lord *Cutts, Sir David Collier, Colonel Tiffney, and Colonel Pipar*. And there is a Letter of the 25th from the Camp, which says, the Articles were agreed on, and wanted only to be Ratified.

This morning my Lord Justice *Porter*, and the Lord Justice *Coningsby*, went hence towards *Kilkenny*, to Ratify the Treaty if it be insisted on.

Bristol, October 5. On the 3d instant arrived here a Vessel, who left *Waterford* on the 30th past, the Master whereof gave an account, that before he came away an Express arrived there with the news of the Surrender of *Limerick*. This afternoon came in a small Vessel, which parted from *Youghill* on Saturday; The Passengers that came in her say, that on Wednesday, Thursday, and Friday last, there came to that place several that had been Prisoners at *Limerick*, who reported, that *Sarsfield* and others had Capitulated for the Surrender of that Garrison; That the Articles were agreed on, and sent to the Lords Justices to be confirmed; And that in the mean time the Irish Town was put into the possession of Their Majesties Forces; And that the Irish were to keep the English Town till the Ratification came from the Lords Justices. This Evening arrived a Vessel, which came from *Kinsale* on Saturday last, and brings a Letter, giving an account as follows:

Kinsale, October 2. We have just now the good News of the Surrender of *Limerick*, our Troops having marched into the Place on *Michaelmas Day*.

Deal, October 6. Colonel *Ayhmer* is come into the *Downes* from the Northward with Their Majesties Ships under his command.

Westminster, October 5. The Parliament met this day, and was again Prorogued to the 22d of this month.
