TO BE OBSERVED AT THE QUEEN'S LEVÉES TO BE HELD AT ST. JAMES'S PALACE, ON BEHALF OF HER MAJESTY.

By Her Majesty's Command,

Gentlemen who propose to attend Her Majesty's Levées are requested to bring with them two large cards, with their names clearly written thereon, one to be left with The Queen's Page in attendance in the Corridor, and the other to be delivered to the Lord Chamberlain, who will announce the name to His Royal Highness.

## PRESENTATIONS.

Gentlemen who propose to present others must send in writing the name of such Gentlemen to the Lord Chamberlain's Office, not later than two days previous to the Levée, in order that the Lord Chamberlain may submit the names to Her Majesty, when, if they are approved, Presentation Cards will be forwarded. Forms for the purpose can be obtained at the Lord Chamberlain's Office.

Gentlemen who wish to be presented officially should communicate with the heads of their Department, who will provide them with the necessary cards and instructions.

THE following Scheme for the adjustment of the property, rights, liabilities &c. of the Urban District Council of Bridlington, in the East Riding of Yorkshire, and for other purposes, as settled by a Committee of Her Majesty's Most Henourable Privy Council, is published in pur-suance of the provisions of "The Municipal Corporations Act, 1882":-

WHEREAS by the Municipal Corporations Acts 1882 and 1885, it is enacted that where a petition for a Charter of Incorporation is referred to the Committee of Her Majesty's Most Honour-able Privy Council, and it is proposed by the Charter to extend the Municipal Corporations Acts to the municipal borough to be created by the Charter, the said Committee of Council may settle a Scheme for the purposes in the said Acts named, and containing such provisions as are in the said Acts particularized.

And whereas in the month of July one thousand eight hundred and ninety-seven certain inhabitant householders of the Urban District of Bridlington, in the East Riding of Yorkshire, petitioned Her Majesty the Queen, praying for the grant of a Charter of Incorporation:

And whereas the said petition for a Charter was referred to the Committee of Council, and it was proposed by the Charter to extend the Municipal Corporations Acts to the municipal borough to be created by the Charter and to incorporate the inhabitants thereof:
