training and exercise, in any year, of all or any part of the Militia be extended, but so that the whole period of training and exercise be not more than fifty-six days.

And whereas it is expedient that the training of such Militia units or individual Militiamen as may be accepted for the Special Service Section of the Militia constituted under an Act passed in the sixty-first and sixty-second years of Her Majesty's reign, entitled the "Reserve Forces and Militia Act, 1898," and of the Regiments, Divisions and Battalions of Militia hereinafter mentioned should be extended beyond the period of twenty-eight days for the year one thousand eight hundred and ninety-nine.

Now, therefore, Her Majesty, with the advice of Her Privy Council, is pleased to order and direct that the period of training and exercise of such Militia units and individual Militiamen as may be accepted for the Special Service Section of the Militia, and of the undermentioned Regiments, Divisions, and Battalions of Militia shall, for the year one thousand eight hundred and ninety-nine, be extended, under the provisions of the before-cited Act, from twenty-eight days to the number of days in each case hereinafter mentioned, that is to say :-

> Militia units or individual Militiamen of the Special Service Section of the Militia, seven (7) days additional to the period of the Regimental Training of the unit or the Militiaman in each case.

And whereas Her Majesty by Order in Council dated the sixteenth day of March, one thousand eight hundred and ninety-two, was pleased to fix the establishment which might be maintained by the Commissioners of Northern Lighthouses, and the amount of the salaries to be paid to the officers of the said establishment out of the Mercantile Marine Fund:
