## "The SCHEME.

. "It is proposed to separate a certain district or portion of the parish of Chatton known as the ancient townships of Weetwood and Cold Martin in the county of Northumberland and diocese of Newcastle and more particularly described in the first schedule hereto from that parish and to annex the same for ecclesiastical purposes to the parish of Wooler in the same county and diocese.

"" It is also proposed to separate another district or portion of the said parish of Chatton being a part of the ancient township of Hetton in the county of Northumberland and diocese of Newcastle, and more particularly described in the second schedule hereto from that parish and to annex the same for ecclesiastical purposes to the parish of Doddington in the same county and diocese.

"It is also proposed to separate another district or portion of the said parish of Chatton being another part of the ancient township of Hetton in the county of Northumberland and diocese of Newcastle and more particularly described in the third schedule hereto from that parish and to annex the same for ecclesiastical purposes to the parish of Lowick in the same county and diocese. "From and after the passing of any Order in Council carrying this scheme into effect the respective Incumbents of the said parishes of Wooler Doddington and Lowick shall have exclusive cure of souls within the limits of the said districts now part of the parish of Chatton and the fees for marriages churchings and burials and other ecclesiastical dues offerings and emoluments arising from the said districts shall thenceforth belong to the respective Incumbents of the said parishes of Wooler Doddington and Lowick to which such districts shall have been respectively annexed.

"That no alteration shall be made as to the patronage or (save as aforesaid) the endowments of any of the benefices affected by this scheme.

## "The FIRST SCHEDULE hereinbefore

referred to.

"All that portion of the parish of Chatton in the county of Northumberland and diocese of Newcastle comprised within the ancient township of Weetwood and also all that portion of the same parish comprised within the ancient township of Cold Martin the boundaries of which two townships are well known and defined.

"The SECOND SCHEDULE hereinbefore ... referred to.

"All that portion of the parish of Chatton in the county of Northumberland and diocese of Newcastle being a part of the ancient township of Hetton in the same county and diocese and bounded on the north by the road leading from Hetton Hall north-west through Hetton Smithy to Hetton Coal Law on the south by the ancient boundary line (shown in the Ordnance survey) between the townships of Hetton and Horton, on the east by the occupation road leading from East Horton through Crook House to Hetton Hall, and on the west by the ancient boundary line between the parish of Chatton and the parish of Doddington as the same is more particularly delineated on the plan hereto annexed and thereon coloured round with a green verge line.

## "The THIRD SCHEDULE hereinbefore referred to.

"All that portion of the parish of Chatton in the county of Northumberland and diocese of Newcastle being part of the ancient township of Hetton in the same county and diocese and bounded on the north by the ancient boundary between the parish of Chatton and the parish of Lowick on the south by the road leading from Hetton Hall through Hetton Smithy to Hetton On the east by the Hetton Burn and Coal Law. on the west by the ancient boundary between the parish of Chatton and the parish of Doddington as the same is more particularly delineated on the plan hereto annexed and thereon coloured round with a red verge line.
