

In the High Court of Justice. — Chancery Division.

Mr. Justice Byrne.—1899. A. No. 014.

In the Matter of the Army and Navy Co-operative Breweries Limited and Reduced and in the Matter of the Companies Act 1867 and in the Matter of the Companies Act 1877.

NOTICE is hereby given that the Order of the High Court of Justice (Chancery Division) dated the 21st day of April 1899 confirming the reduction of the capital of the above named Company from £100,100 to £86,488 10s. and the Minute approved by the Court showing with respect to the capital of the Company as altered the several particulars required by the above Statutes were registered by the Registrar of Joint Stock Companies on the 13th day of May 1899.
