GENERAL ORDER of the Local Government Board : Altering Regulations as to Orders drawn by Guardians upon Treasurer :-

Chorlton Union.

To the Guardians of the Poor of the Chorlton Union ;-

And to all others whom it may concern.

WHEREAS by a General Order dated the twenty-fourth day of July, one thousand eight hundred and forty-seven, addressed to the Guar-dians of the Poor of the Chorlton Union, amongst others, the Poor Law Commissioners made certain rules and regulations relating to the administration of relief to the Poor within the said Union, and by Article 84 of the said Order directed that the Guardians of the Poor of the said Union should pay every sum greater than five pounds by an order drawn upon their Treasurer and signed by the presiding Chairman and two other Guardians at a meeting, and countersigned by the Clerk :

And whereas it is expedient that the said General Order should be altered as hereinafter mentioned :

Now therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, by this Our Order Direct that, so far as regards the payment of any salary or other remuneration by the Guardians of the Poor of the Chorlton Union to any of their officers, assistants, or servants, Article 84 of the
