Great Berkhampstead Waterworks. (Dissolution of the Great Berkhampstead Waterworks Company, Limited; Incorporation of Shareholders into New Company; Consolidation of Existing Share Capital into Stock; Power to Company to raise further Capital by Stock and by Borrowing; Supply of Water within Present and Extended Limits of Supply; Improvement and Maintenance of Existing Waterworks; Supply of Water by Agreement in Bulk; Prevention of Waste, Contamination, &c.; Meters and Fittings; Breaking up of Roads; Water Rates, Rents, and Charges; Alteration of Number and of Qualification of Directors of Company; Incorporation and Amendment of Acts.)

TOTICE is hereby given, that application is intended to be made to Parliament in the next Session by the Great Berkhampstead Waterworks Company, Limited (hereinafter called "the Limited Company"), for an Act for all or some of the following objects and purposes (that is to say):—

1. To dissolve the Limited Company and to cancel and annul their Memorandum and Articles of Association and Special Resolutions and other instruments under which they are now acting, and to provide for the winding up of that Company, and the incorporation of a new company (hereinafter called "the Company"), including the proprietors of the Limited Compary, or some of them, with or without other

persons or corporations.

2. To provide for the consolidation of the different classes of shares of the Limited Company and the conversion of the same into stock, bearing an uniform rate of dividend, and to make such provision with respect to the capital and shares of the Limited Company as may be necessary or expedient, and as may be prescribed by the intended Act, and to authorise the Company to raise further capital by creating and issuing a further amount of stock, and to provide for the vesting and apportionment of such capital and shares, and of any new shares or stock in and among the shareholders of the Company, and to enable the Company to raise additional capital by shares or stock, and borrowing on mortgage or by debenture stock, and to attach to such shares and stock or any part thereof respectively a preference or priority of dividend, and other advantages, and to make provision with respect to the payment of dividends thereon and with respect to the number and qualification of the directors of the Company, and the the regulation and management of the affairs of the Company.

3. To provide for the vesting in the Company of all the undertaking, lands, waterworks, wells, tanks, mains, pipes, meters, valves, sluices, hydrants, machinery, apparatus, plant, stock, effects, buildings, rights, easements, moneys, securities, choses in action, and other real and

trust for them, together with the benefit of all contracts and engagements entered into by or on behalf of the Limited Company, and to empower the Company to hold, continue, improve, and maintain such lands, works, and

other property.
4. To empower the Company to supply water within the limits for the supply of water defined by Section 4 of the Great Berkhampstead Water Order, 1885, confirmed by the Water Orders Confirmation Act, 1885, being the existing limits of supply of the Limited Company, and to add to and include within such limits all or some part or parts of the parishes of Flaundon and Chesham, in the county of Buckingham, and for that purpose to maintain, alter, improve, enlarge, and extend the wells, pumps, reservoirs, tanks, conduits, mains, pipes, and waterworks of the Limited Company, and to take and use the springs and waters which can be taken or intercepted thereby.

5.
