(Vesting of Tottenham Lammas Lands in District Council; Provision, Laying out, Control and Management of Open Spaces and Recreation Grounds; Ascertainment of Compensation to Owners of Lammas Lands; Appointment of Arbitrator; Extinction of Lammas and other Rights; Exchanges and Leases of Lammas Lands; Further Powers as to Commons; Transfer of Waste Lands Fund to District Council; Sale and Exchange of Lands acquired from East London Waterworks Company; Contributions towards Open Spaces; Provision as to Bands, Entertainments, &c.; Buildings, Streets, &c.; Sewerage, Drainage, and other Provisions for Sanitation and Government of District; Sky-signs; Travelling Vans, &c.; General further Local Improvement and Police Powers; Altering System of Election of Council; Electric Lighting; Application of Funds, Rates, and Charges; Borrowing Powers; Amendment of Acts.)

NOTICE is hereby given that application is intended to be made to Parliament in the ensuing session by the Tottenham Urban District Council (in this Notice referred to as "the Council") for leave to bring in a Bill for the purposes or some of the purposes hereinafter mentioned, namely:—

To vest or provide for vesting in the Council certain lands in the parish and Urban District of Tottenham, in the county of Middlesex (hereinafter referred to as "the District"), which lands are or are reputed to be subject to Lammas rights and to provide for the extinction and regulation of such rights upon such terms and conditions and in such manner as may be defined in the Bill, or to empower the Council to purchase and acquire the said lands or any of them either by agreement or compulsion.

To empower the Council to hold the said lands and any part or parts thereof as and for an open space or spaces for public use and to provide any recreation ground or recreation grounds thereon.

To provide for the appointment of an Arbitrator to determine all questions of compensation arising out of the vesting of the said lands in the Council in manner aforesaid and to fix the purchase money or consideration to be paid to the Owners and parties interested in the said lands in respect thereof.

respect thereof.
To fix and regulate the procedure of such Arbitrator and the subject matters of his award and to establish all necessary machinery for the hearing and adjudication of matters referred to him.

To provide that the Council may either terminate or extinguish any existing leases tenancies easements rights of way Lammas, grazing, and other rights over upon or affecting the said lands or any part thereof or may leave the same or any of them subsisting for such period and

subject to such conditions as may be defined in the Bill.

The Bill may provide that the conversion of the said lands or any parts thereof into open spaces or recreation ground shall be in substitution for and in discharge of any pecuniary payment and other compensation to the persons having Lammas or similar rights over the lands or it may provide for the ascertainment of a sum of money to represent the value of the rights extinguished and for the application of such sum in aid of the conversion of the said lands into open space or recreation grounds or the extension and improvement thereof.

To authorise the sale or lease of any of the Lammas lands when vested in the Council and which may not be suitable for the purpose of an open space or recreation ground, or the exchange of parts of the said lands for other lands suitable for the purpose, and for the application of the proceeds of any such sale or lease to and for the purposes of the intended Act, and to limit the extent of the said lands to which any such powers of sale or lease apply.

To confer further powers on the Council for the control, regulation, and management of any commons Lammas waste or commonable lands in the district and the acquisition of any estate and interest therein and to empower the Counci to plant drain fence and improve any parts thereof; and to transfer to the Council any funds now in the hands of the vestry or of any trustees arising from any sale or disposition of any of such lauds and to transfer to the Council any powers of the said vestry and trustees in relation to commons Lammas waste or commonable lands.

To empower the Council to sell, exchange, or dispose of any land conveyed to them under the provisions of the East London Waterworks Act, 1897, and to provide for the application of any purchase money or rents arising therefrom in cr towards purposes of the open spaces or recreation grounds.

To empower the Council to provide swimming baths, lakes, or ornamental pieces of water, and to regulate the use thereof for boating, skating, or other purposes, and to provide grounds for cricket, football, and other games, for drilling and other purposes, and to provide bands and apparatus for games and other things, and to erect and maintain refreshment rooms, museums, pavilious, and other buildings, and to let the same or any of them and charge for the use thereof.

To appoint constables and officers, and to confer on them powers for the control of the open spaces and grounds.

To confer various powers on the Council in connection with the proposed open space or recreation grounds and for the control and regulation thereof.

To empower the London County Council to contribute out of their public funds monies in aid of the provision of such open space.

To confer powers on the Council and to make provisions with respect to the following matters or some of them, viz.:—Ventilation of courts and buildings; regulating the formation of courts and habitable rooms, roofs and projections of buildings, materials and dimensions of cornices, roofs and buildings, means of escape from buildings, accesses and stairs of tenement houses, fire resisting materials, removal of dilapidated and neglected buildings, definition of lines of street, intersecting streets, junctions and continuations of streets, prohibition of building except in defined streets, regulations as to construction of bridges, prevention of projections over streets; sky signs; regulating new buildings and re-
