erection or alteration of buildings; removal of trees over roads and paths, regulating erection of temporary and movable buildings, lighting of common stairs, street advertisement.

For the prevention of the spread of infectious or contagious diseases through food supply, clothes, or attendance at schools within the district of persons whether residing in or outside the district, the regulation of dairymen and the milk supply of the district, the notification of infectious diseases, and otherwise with respect to the prevention of the spreading of infectious or contagious diseases, and to empower the Council to prohibit the use of houses or buildings as private hospitals for persons suffering from infectious or contagious diseases, and to license, register, and regulate and inspect such houses.

With respect to the occupation of cellars, common lodging houses, and the keepers thereof and the registration of such houses and keepers.

With respect to the exclusion and removal from the district of gipsies, squatters, settlers, and exhibitors of indecent books, prints, &c., or persons brawling, fighting, or quarrelling, or idle or disorderly persons, and the apprehension of all offenders, so that all such persons may be dealt with according to law.

Prevention of sale of unsound meat and improper foods, cleansing of cisterns, drainage of houses, protection of drains, compulsory provision of proper water supply to houses and of proper drains; power of eutry on premises, provision of public conveniences and lavatories, regulation of cellar dwellings, works for ventilating sewers, covering in ditches, prohibition or regulation of vans, tents, sheds, &c., dangerous structures and common lodging houses.

To provide for the levying and recovery of fines and penalties in respect of the breach of any provisions of the intended Act and of any bye-laws made thereunder.

To make provision as to the rating of houses, occupied during any part of the period for which a rate is made, closing and letting of the public baths.

To make provision with respect to the retirement of members of the Council, and to provide for annual elections of one-third instead of triennial elections of the whole number of the Council.

To authorise the Council to produce store and supply electrical energy for public and private purposes within the district and for those parposes to erect, maintain, work and use stations, storehouses, buildings, dynamos, engines, batteries, machinerŷ, apparatus, works and appliancês for the production, storage, and distribution of electricity, and to lay down, set up, mainfain, renew and remove, either above or underground, or otherwise, pipes, tubes, wires, casings, troughs, inspection boxes, posts, and other works and apparatus.

To empower the Council to make and recover rates and charges in respect of such supply and to confer upon the Council all or any of the powers of the Electric Lighting Acts 1882 and 1888 and to incorporate in the Bill and make applicable to the Council and the District with or without exceptions and modifications all or some of the provisions of the Electric Lighting (Clauses) Act 1899.

To empower the Council for the purposes of their electric undertaking within the district to open, break up, alter and interfere with roads, highways, streets, bridges, railways, canals, tramways, sewers, drains, mains, pipes, tubes, wires and other apparatus and things, and to make special provisions in relation to the exercise of such powers and to break up any streets or bridges across or over railways or canals within the district not repairable by a local authority without the consent of the Board of Trade and to exempt the Council from the restrictions imposed by Section 13 of the Electric Lighting Act, 1882.

To enable the Council from time to time to extend the provisions of any existing bye-laws, including the matters or any of the matters mentioned in this notice and to make, enforce, vary or rescind bye-laws, rules and regulations for all or any of the purposes mentioned in this notice, and to confer upon the Council all necessary powers, privileges and authorities for enabling them effectually to carry out the provisions of the Bill, and to provide for the imposition and recovery and application of penalties for breach or non-observance of any of the provisions of the Bill, or any bye-laws licence, rules and regulations now existing within the district or which may be made under the provisions of the Bill, and to make further provisions with respect to legal proceedings by the Council and their officers and appeals against nuisances orders.

To authorise the Council for all or any of the purposes of the Bill to apply their funds, rates and revenues and any moneys which they are authorised to raise or which may be payable to them under the Bill or otherwise, and to make and levy additional, and to alter existing rates and charges, and to confer exemptions from the payment of rates and charges and to borrow or raise money on the security of any such funds, rates, or revenues or of any property of the Council, by mortgages, debentures or debenture stock, or in such other manner as the Bill may prescribe.

To incorporate with the Bill so far as may be deemed necessary, and with such exceptions and modifications as may be expedient, the Lands Clauses Acts; the Gasworks Clauses Acts, 1847 and 1871; and to amend and extend the Tottenham Local Board Act, 1890.

Duplicate plans showing the lands proposed to be vested in the Council or taken under the powers of the Bill together with a book of reference to such plans, and a copy of this Notice will, on or before the 30th day of November, be deposited for public inspection with the Clerk of the Peace for the county of Middlesex, at his office at the Guildhall, Westminster, and on or before the same day a copy of the said plans and book of reference, together with a copy of this Notice, will be deposited with the Clerk of the Uouncil at his office, Coombes Croft House, No. 712, High-road, Tottenham.

Printed copies of the proposed Bill will, on or before the 21st day of December next, be deposited in the Private Bill Office of the House of Commons.
