Arrêté.

Nous Gouverneur p.i. de l'Ile de la Réunion,
Vu l'article 9 du sénatus-Consulte du 1^e Mai 1854;

Vu l'article 40 de l'ordonnance du 21 Août 1825;

Vu le décret du 31 Mars 1897 sur la police sanitaire et le décret modificatif du 20 Juillet 1899;

Vu l'arrêté du 27 Juillet 1899 et l'arrêté du 25 Août de la même année;

Vu l'installation au Lazaret de la Grande Chaloupe d'une étuve à vapeur sous pression permettant de désinfecter au débarquement les effets et bagages des passagers provenant des pays contaminés;

Sur avis conforme du Conseil sanitaire et la proposition du Directeur de la Santé,

Avons arrêté et arrêtons :

ART. 1er. Est abrogé l'arrêté du 25 Août dernier, sauf et ce qui concerne les marchandises dont l'introduction demeurera interdite tant que l'installation de la station sanitaire ne sera pas achevée; les machines désinfectées avant l'embarquement seront seules admises dans la Colonie, dans les conditions antérieurement stipulées.

ART. 2. Les passagers provenant des pays contaminés purgeront leur quarantaine en rade où sous voile, jusqu'à nouvel ordre. La durée de cette quarantaine est fixée à 12 jours, non compris le temps de traversée, conformément au décret du 20 Juillet 1899 modificateur du décret du 31 Mars 1897, et portant règlement de police sanitaire maritime dans les colonies françaises et pays de protectorat.

ART. 3. Le Procureur Général et le Directeur de la Santé sont chargés, chacun en ce qui le concerne, de l'exécution du présent arrêté qui sera communiqué et enregistré partout où besoin sera et inséré au Journal et au Bulletin Officiels de la Colonie.
