WILD BIRD PROTECTION (ENGLAND).

The Wild Birds Protection (County of London) Order, January, 1900. Dated 10th January, 1900.

IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of London, I hereby make the following Order :--

I. This Order may be cited as "The Wild Birds Protection (County of London) Order, January, 1900."

BIRDS.

Close Time Extended.

II. The time during which the killing and taking of Wild Birds is prohibited by the Act of 1880 shall be extended, so far as concerns the county of London, so as to be from the 1st day of February to the 31st day of August in each

Certain Birds protected during the whole of the Vear.

III. During the period from the 1st day of September in any year, to the 31st day of January following, both days inclusive, the taking or killing of any of the following kinds of Wild Birds is prohibited throughout the County of London:

Bearded Tit (Reedling or Reed Pheasant), Blackbird, Black Cap, Blue Tit, Buntings, Buzzard, Chaffinch, Chiff Chaff, Cole Tit, Coot, Cuckoo, Flycatchers, Garden Warbler, Goldencrested Wren, Goldfinch, Great Tit, Gulls, Hedgesparrow (or Dunnock), Hobby, Honey Buzzard, Kestrel, Kingfisher, Landrail (or Corncrake), Lark, Lesser White Throat, Linnet, Long-tailed Tit, Magpie, Martins, Merlin, Nightingale, Nightjar, Nuthatch, Osprey, Owls, Redstart, Reed Warbler, Robin (or Redbreast), Sedge Warbler, Shrikes, Starling, Stonechat, Swallow, Swift, Thrushes,
