No. 26.—ITALY—GULF OF SALERNO.

Amalfi Lighthouse—Desroyed.

THE Italian Government has given notice, dated 27th December, 1899, that the lighthouse, from which a red fixed light was exhibited on Amalfi Mole Head, has been destroyed by a landslip; the light is therefore discontinued.

Approximate position, lat. 40° 38' N., long. 14° 36' E.

THE Netherlands Government has given notice, dated 29th December, 1899, that a reef about 70 yards in extent, and with a depth of 3 fathoms over it, has been discovered to the northward of Pasi or Varkens Island; it is situated with the north point of Varkens Island bearing S. 10° E., distant 1½ miles, and Apat Batu S. 8½° E.
