# THE FAIRS ACT, 1871. (34 and 35 Vict, cap. 12.) POOLE FAIRS.

THE Secretary of State for the Home Department hereby gives notice that, by Memorial dated 11th January, 1900, a representation has been duly made to him by the Town Council of Poole that Fairs had been annually held at Poole on the Feast of the Holy Apostles Philip and James, and seven following days, and on the day of All Souls and seven following days, and that it would be for the convenience and advantage of the public that such Fairs should be abolished.

On the 23rd day of February, 1900, the Secretary of State will take such representation into consideration, and any person who may desire to object to the abolition of the Fairs, should intimate his objections to the Secretary of State before that day.

# WILD BIRD PROTECTION.

The Wild Birds Protection (County of Leicester) Order, 1900.

Dated 25th January, 1900.

IN pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1896, and upon application by the County Council of the Administrative County of Leicester, I hereby make the following Order :---

#### Title.

I. This Order may be cited as "The Wild Birds Protection (County of Leicester) Order, 1902."

#### BIRDS.

Additions to the Schedule of the Act of 1880.

II. The Wild Birds Protection Act, 1880, shall apply within the Administrative County of Leicester to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act :--

Hedge Sparrow, Spotted Fly Catcher, Pied Fly Catcher, Tree Creeper, Sand Martin, Martin, Swallow, Wagtails, Swift.

Certain Birds protected during the whole of the Year.

III. During the period from the 1st day of August in any year, to the last day of February following, the taking or killing of the Goldfinch and Kingfisher is prohibited throughout the County of Leicester.

# EGGS.

Certain Eggs protected throughout the County.

IV. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the County of Leicester for a period of five years from the date of this Order : -

Black Cap Warbler, Buntings, Chiff Chaff, Cole Tit, Ducks (Wild) all species, Fly Catchers, Firecrested Wren, Golden-crested Wren, Goldfinch, Lesser (Dab Chick) Grebe, Great Crested Grebe, Hawks, Buzzard, Honey Buzzard, Kestrel, Merlin, Hobby, Osprey, Kingfisher, Lesser Whitethroat, Long-tailed Tit (Bottle Tit, Jack-o'-Bo-peep),
