"The Consolidated Chapelry of Saint Paul

Cwm, comprising :--"I. All that portion of the new parish (sometime consolidated chapelry) of Christ Church Ebbw Vale in the county of Monmouth, and in the diocese of Llandaff which is bounded upon part of the north and upon part of the east by the parish of Aberystruth, upon the remaining part of the east and upon the south-east by the hereinafter described portion of the district chapelry of Saint Michael Abertillery upon the south-west by the hereinafter described portion of the parish of Bedwellty, upon the west by the new parish of Tredegar which said cures are all situate in the county and diocese aforesaid, and upon the remaining sides that is to say upon the north-west and upon the remaining part of the north by an imaginary line commencing upon the boundary which divides the said new parish of Tredegar from the new parish of Christ Church Ebbw Vale aforesaid at the point where the parish road leading over the mountain called Cefn Manmoel past Gareg-pica and Ton-y-fedw towards Manmoel is joined by the road leading from Ton-y-fedw aforesaid into High street Ebbw Vale and extending thence north-eastward along the middle of the last-mentioned road for a distance of thirty-nine chains or thereabouts to a point in the middle of such road distant thirteen chains or thereabouts south of its junction with High-street aforesaid and extending thence in a direct line due east for a distance of thirty-two chains or thereabouts (thereby passing to the south of the houses called Boundary - row crossing Victoria - road near its junction with Park road and the road leading to Victoria Colliery and passing to the north of the buildings belonging to the said colliery) to a point in the middle of the Ebbw River, and extending thence southward along the middle of the said river for a distance of nineteen chains or thereabouts to the centre of Dyffryn Bridge which carries the road leading from Victoria Iron Works through Dyffryn to the house called Twynffrwd over the said river, and extending thence first south-eastward then northcastward then again south-eastward and then eastward along the middle of the last-mentioned road for a distance of thirty-nine chains or thereabouts to a point in the middle of such road opposite the northern end of the said house called Twynffrwd and extending thence due east and in a direct line for a distance of twelve chains or thereabouts to the boundary which divides the said new parish of Christ Church Ebbw Vale from the parish of Aberystruth aforesaid.

"II. And also all that contiguous portion of the said district chapelry of Saint Michael Aber-tillery which is bounded upon the south-east by the parish of Llanhilleth in the county and diocese aforesaid upon the south-west by the hereinafter described portion of the parish of Bedwellty aforesaid upon the west by the above described portion of the new parish of Christ Church Ebbw Vale aforesaid, upon the north east | say :-

by the parish of Aberystruth aforesaid and upon the remaining side that is to say upon the east by an imaginary line commencing upon the boundary which divides the said parish of Aberystruth from the district chapelry of Saint Michael, Abertillery aforesaid at the point where the road which leads past Pen-crug glâs over the mountain called Cefn-yr-Arrail towards Abertillery is joined by the road which leads past Hafod-y-dafal to Aberbyg and extending thence generally southward along the middle of the last-mentioned road for a distance of one mile and twenty chains or thereabouts to the boundary which divides the said district chapelry of Saint Michael Abertillery from the parish of Llanhilleth aforesaid.

"III. And also all that contiguous portion of the parish of Bedwellty aforesaid which is bounded upon the south-east by the parish of Llanhilleth aforesaid upon the north-east partly by the above described portion of the said district chapelry of Saint Michael Abertillery and partly by the above described portion of the new parish of Christ Church Ebbw Vale aforesaid upon the north west by the said portion of the said new parish of Christ Church Ebbw Vale, and upon the remaining side that is to say upon the southwest by an imaginary line commencing at the point where the boundary which divides the said new parish of Christ Church Ebbw Vale from the parish of Bedwellty aforesaid meets the boundary which divides the said parish of Bedwellty from the new parish of Tredegar aforesaid in the middle of the said parish road which leads over the mountain called Cefn Manmoel past Gareg-pica and Ton-y-fedw towards Manmoel as aforesaid and extending thence generally south-eastward along the middle of the said parish road for a distance of one mile and seven chains or thereabouts to its junction near the house called Ton-y-fiald with the road which leads past Ton-yr-efail-fach and Pen-y-fan-uchaf towards Ton-tir-bel, and extending thence generally southeastward along the middle of the last-mentioned road for a distance of one mile and a half or thereabouts to the boundary which divides the said parish of Bedwellty from the parish of Llanhilleth aforesaid."

And whereas the said representation has been approved by Her Majesty in Council : now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts ; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forth-with registered by the Registrar of the said diocese of Llandaff.
