"We the Ecclesiastical Commissioners for England in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth chapter seventy-seven, and of the Act of the fifth year of Your Majesty Se sion two, chapter twenty-six, have prepared and now humbly lay before Your Majesty in Council the following scheme for providing the Bishop of Bangor with a more convenient house of residence.

"Whereas the house and premises with the appurtenances thereto belonging situate in the city of Bangor are now vested as and for an episcopal

residence in the said Bishop of Bangor.

"And whereas it has been represented to us by the Right Reverend Watkin Herbert now Bishop of Bangor and it has been made to appear to us that the said house has no architectural or antiquarian interest that it is badly constructed and inconveniently arranged and that it could not at any reasonable outlay be made suitable for an episcopal residence.

"And whereas the site of the said residence lies in the basin of a small brook now converted into a sewer and is subject to the discharge of large quantities of water from the higher ground adjacent causing the said house and premises to be

damp and insanitary.

"And whereas under the circumstances hereinbefore set forth it appears to us to be expedient and likely to conduce to the permanent benefit of the See of Bangor that the sale of the said house and premises with the appurtenances thereto belonging should be effected in the manner hereinafter recommended and proposed.

"Now therefore with the consent of the said Watkin Herbert Bishop of Bangor (in testimony of which consent he has signed this scheme and sealed the same with his episcopal seal) we the said Ecclesiastical Commissioners for England humbly recommend and propose as

follows that is to say :-

"That the said Bishop be authorized and empowered to sell for such price or prices and at such time or times and in such manner as shall be approved by us and to transfer and convey to any purchaser or purchasers by an assurance or assurances to be made in manner and form approved by us the said Ecclesiastical Commissioners under our common seal the whole estate right title and interest of him the said Watkin Herbert, Bishop of Bangor and of his successors of in and to the said house and premises situate at Bangor aforesaid with the appurtenances thereto belonging as the same are now vested in him and that all moneys received by or on account of the said house and premises and the appurtenances thereto belonging or of any part thereof shall be by him the said Bishop paid over to us the said Ecclesiastical Commissioners and shall be held by us and applied by the said Bishop for the purposes and in the manner next hereinafter mentioned but with and subject to our approval and at such times and in such manner as shall appear to us to be expedient, that is to say, firstly in defraying all costs charges and expenses of and incident to the sale of the said house and premises situate at Bangor aforesaid and secondly in defraying the cost of providing in such manner and at such time as shall be approved by us the said Ecclesiastical Commissioners a more suitable episcopal residence with the appurtenances thereto which shall be within a reasonable distance from the city of Bangor aforesaid.

"And we further recommend and propose that so soon as the above-mentioned new episcopal residence shall have been provided the said Watkin Herbert, Bishop of Bangor

or his successors shall at his or their personal charge and expense insure and keep insured from loss or damage by fire the same residence with the outbuildings and appurtenances thereof such insurance being effected in one of the public offices of assurance in London or Westminster for such a sum not being less than the sum which may be certified by the Ecclesiastical Commissioners' Surveyors as the probable cost of entirely rebuilding the same in case of fire as may be determined by us the said Ecclesiastical Commissioners and that such Bishop shall within fourteen days after any premium for such insurance shall have become payable deliver to us the receipt for the same and that in case of any loss or damage by fire to the said residence any and every sum of money receivable under such insurance shall become and be payable and be paid to and deposited with us in trust to be applied and we recommend and propose that the same together with any interest and accumulation thereof shall be applied by us towards the rebuilding or repairing and reinstating of the said residence or any part thereof which may have so suffered loss and damage in such manner as shall be determined on by us with the concurrence of the Bishop of Bangor for the time being.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in conformity with the provisions of the said Acts or either of them or of any other Act or Acts of

Parliament."

And whereas the said scheme has been approved by Her Majesty in Council: now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and Her Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Bangor.
