" And whereas no assignment of the patronage of the said district and new parish of Saint Matthias Stoke Newington was made by the said Order and no such assignment has since been

"And whereas a capital sum of five hundred pounds sterling has been contributed and paid to the credit of our account at the Bank of England by Richard Foster, of Homewood, Chislehurst, in the county of Kent, Esquire, towards the augmentation of the endowment of the said district and new parish of Saint Matthias, Stoke Newington, and for the benefit of the Vicar or Incumbent thereof, and we, the said Ecclesiastical Commissioners for England, have in respect of the said sum agreed with the said Richard Foster, and have undertaken to provide and pay by equal quarterly payments on the first day of February, the first day of May, the first day of August and the first day of November in each and every year to the Vicar or Incumbent of the said district and new parish of Saint Matthias, Stoke Newington (being duly licensed thereto) the yearly sum of fifteen pounds so long as the said capital sum shall remain in our hands.

"And whereas the said capital sum of five hundred pounds sterling was so contributed and paid by the said Richard Foster as aforesaid upon the understanding that (such arrangement appearing to us expedient) the whole right of patronage of the said district and new parish of Saint Matthias, Stoke Newington, and of the nomination of the Vicar or Incumbent thereto should be assigned to the Bishop for the time being of the diocese within which the same benefice may from time to time be situate, in the manner hereinafter

recommended and proposed.

"And whereas it has been made to appear to us that the assignment of the patronage and right of nomination and presentation of and to the said district and new parish of Saint Matthias, Stoke Newington, which has been proposed to us by the said Richard Foster as aforesaid may properly be

"Now therefore we the said Ecclesiastical Commissioners for England humbly recommend and propose that the whole right of patronage of the said district and new parish of Saint Matthias, Stoke Newington, and of the nomination of the Vicar or Incumbent thereto shall, without any conveyance or assurance in the law other than this scheme and any duly gazetted Order of Your Majesty in Council ratifying the same, and upon and from the day of the date of the publication of such Order in the London Gazette, be assigned to and be absolutely vested in and shall and may from time to time be exercised by the Bishop for the time being of the diocese within which the said district and new parish of Saint Matthias Stoke Newington may from time to time be situate.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures | thousand pounds sterling was so contributed and
